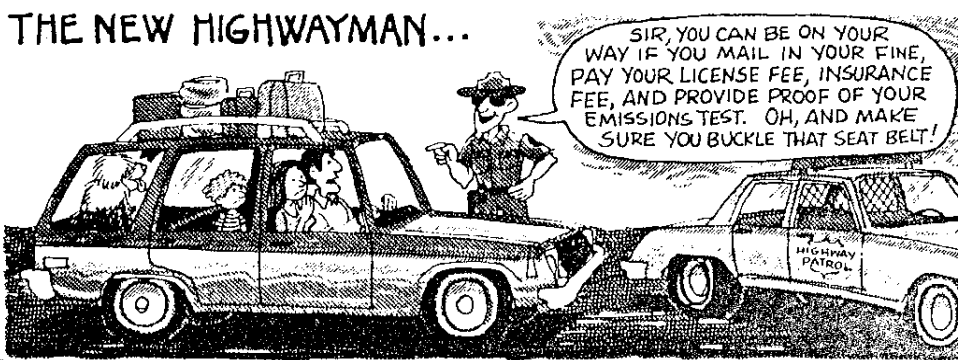

HIGHWAY WARS

and don't forget your R.W.C. and please blow in the breathalyzer!

An increase in violent highway battles between citizens and police is being anticipated by law enforcement in **America**, as many citizens begin to arm themselves in defense. New laws are being established with this scenario in mind.....

The ideology of "just let Big Brother take care of you" is not acceptable to intelligent Americans who realize that governmental intrusion into their private lives poses a greater threat to the citizen's security than does any other source of trouble.

A good example of the "Big Brother" concept can be seen in the continuing increase in motor vehicle laws such as the motorcycle helmet and auto-seatbelt rules. Perhaps there are ulterior motives lurking behind these kinds of laws.....

LURKING MOTIVES?

There is no doubt that in case of an accident, the seat-belt is effective in reducing injuries. So what? But since when is it the function of government to **mandate** specific behavior from private citizens? An individual should be sovereign over his own life according to **natural law**.

Of course, claims are made regarding the economical implications to society collectively-insurance costs, the worker's productivity and down time, etc. Has life in "The Great Society" become **that** complexly entangled to where our every individual movement so significantly effects everyone else?

Have we willingly sacrificed our individual liberties for the convenience of such an un-

natural degree of regimentation?

If the problem of accident injuries is so great, why don't we outlaw the consumption of alcoholic beverages--entirely? Return to "prohibition". After all, practically everyone supports laws regarding other "controlled substances," some of which are obviously less potentially intoxicating than alcohol. And it has been responsible for more than half of the of the injury-accidents that occur on our highways, has it not?

There are deliberate reasons why various laws are applied so arbitrarily. We can be certain that "recreational drugs," including alcohol and other substances, legal as well as illegal, will continue to be made available to the public - through predetermined channels - because like any addictive substance, it puts the control of a persons life into the hands of others. And it brings great profits for those who have cornered the market using their influence within government. By design, illegal use of drugs serves to justify the need for more social controls, restraints, and even more governmental programs.

THREAT TO FREEDOM?

Police "protection" and highway supervision represent a potential threat against natural freedom of America. Consider now the advantage a seat-belt law gives to the law enforcement officer in a vehicle-stop scenario:

The officer observes some type of violation and proceeds to signal the offending motorist to pull over to the side of the road. Whatever the offense may have been is irrelevant to what I am about to point out next...

There is only one way the officer can now for certain that the vehicle occupants are wearing seat-belts and that is for the occupants to continue wearing them at the moment the officer physically walks over to the vehicle and looks directly into the passenger compartment. The officer may be looking for things other than seat-belts, but the passengers--**if properly wearing the belts as required by law**--will remain seated in the vehicle, **restrained**, and positioned facing forward.

Ideally, the vehicle occupants should keep their hands visible to the officer. The driver should shut off the motor and be ready to show papers, license, and to answer questions. This provides the officer with an element of predictability and reduces the potential for a life-threatening maneuver to be successfully directed against him. A citizen who deviates from these procedures would be asking for trouble.

Any vehicle occupant who is observed by an officer **not** to be wearing a seatbelt, or even attempting to exit the vehicle during a vehicle stop, can not only be cited for breaking the seat-belt rule, but will immediately be considered as behaving in a potentially threatening manner against the officer, with an appropriate response from the officer.

Any violation of law which is seen by a police officer provides sufficient cause to approach the offending party, treating them as subject to official arrest - if for no other reason but "disorderly conduct" - at the officer's discretion.

Police officers are trained to approach every vehicle-stop situation with the same high degree of caution. They will use whatever force they feel is necessary to insure their own safety.

LEGALLY RESTRAINED

Travellers on our roads and highways are becoming **legally restrained prisoners**, yielding to the dominating authority and government-sanctioned highway piracy.

Property seizure laws have given authorities more power and **incentive** for abuses of power. Officials are regarded as "heros" by the gullible public when the news media reports stories of "suspected" drug trafficking along with supposedly "illegal" weapons and other items of private property. Yet in many cases, no drugs are reported found.

Consider also the ease in which illegal substances can be planted to "frame" an unsuspecting victim - especially ones who may have "ruffled some feathers." As American neo-patriots, this is what we may soon be facing with increasing incidence.

What extremes should a citizen have to take in defending himself, regardless of who the attacker might be? You may soon find yourself having to make that decision....

(Luke 11:46) "...Is not this the fast that I have chosen? to loose the bands of wickedness, to undo the heavy burdens, and to let the oppressed go free, and that ye break every yoke?" (Isaiah 58:6)

THE SECULAR PRIESTS OF THE LEGAL ARISTOCRACY

"Is not liberty the freedom of every person to make full use of his faculties, so long as he does not harm other persons while doing so? Is not liberty the destruction of all despotism -- including, of course, legal despotism?" -- F. Bastiat

Idolatry comes in many forms -- both garish and subtle. It is anything that man places between himself and his Creator -- even man's law in place of God's law.

TEMPLE OF THE RATS

The above heading, "Temple of the Rats," was the title of a bizarre article in the National Enquirer which told about a holy temple in India where thousands of squealing, scampering rodents are worshipped like gods.

But the priests and local village people of Deshnoke never call them rats--they call them "kabas" which, we are told, are reincarnated children of one of their goddesses. (I think Christians know better).

They believe that when the kabas die, they are reborn into the families of the village.

"The rats are incredibly pampered," the article relates. "At 4 am every morning, as ceremonial drums play, the priests march out with trays of wheat and molasses porridge that is cooked in a huge vat overnight.

As the rats devour breakfast, pilgrims stream in bringing more sumptuous foods and watch in reverence as these holy critters spend the day frolicking, fighting or sleeping and, of course, eating."

IDOLATRY, AMERICAN STYLE

The person that sent us the above-mentioned article wrote these words across it: "The depths that idolatry leads to!... This is an eye-opening example."

As we of the Christian West stand aghast at the idolatry of heathen nations such as India many fail to recognize the "temples of rats" we have in our own nations--in the religious, entertainment, and political realms.

God and His righteousness is cast aside as His covenant people of Anglo-Saxondom set up in its place the idols of humanism.

"Professing themselves to be wise, they became fools. And changed the glory of the uncorruptible God into an image made like unto corruptible man, and to birds, and four-footed beasts, and creeping things." (Romans 1:22,23).

In times past, our forefathers of ancient Israel fashioned four-footed beasts of gold, set them on pedestals, and worshipped them. Today we take two-footed beasts, attire them in glittering, outlandish costumes, grotesquely paint their faces, give them amplified guitars, set them on stages, incite them to devilish howling, and then permit our sons and daughters to worship them.

How far behind in our idolatry are we from India's "Temple of the Rats?" They call their vermin "kabas"; here in America we also give their counterparts more respectable names. Instead of "vermin" they are called Hollywood entertainers, politicians, lawyers, judges, etc. We will direct our attention in this study to the pampered high priests of the legal aristocracy: lawyers, lawyer-judges, and lawyer-politicians.

This legal aristocracy reminds us of another "temple of the rats" located in our nation's capitol. Its 545 devotees--435 congressmen, one president, and nine Supreme Court justices (most of them lawyers)--gaze with reverential obeisance at the coddled, overfed lobbyists of the Israeli State as they scamper about the halls of Congress, consuming huge trays of "lettuce" laid out for them (compliments of the taxpayers).

Listen closely, in the near future you may be hearing the early morning ceremonial drums.

This in turn reminds us of a statement in the Israeli paper Haaritz: For the \$4.25 million Israel(i) has paid to prime the U.S. Congress, Israel(i) will receive a U.S. grant totalling \$2.6 BILLION. For its money, therefore, Israel(i) will have struck the bargain of the century, receiving an interest of 60,000 per cent on its original investment!...Israel(i) is not the 51st state of the United States of America as some would like to think; rather, the U.S. Congress is one of the occupied areas of Israel(i)." (1)

LEGALITY IS NOT LAW

In our opening statement we read that one form of idolatry is supplanting God's Law with man's law. Rousas John Rushdoony explores this thought in some detail in his book, "The Institutes of Biblical Law."



"The commandment, 'Thou shalt have no other gods before me,' means also 'Thou shalt have no other powers before me,' independent of me or having priority over me. The commandment can also read, 'Thou shalt have no other law before me.' The powers which, today more than ever, present themselves as the other gods, are the anti-Christian states. The anti-Christian state makes itself god and therefore sees itself as the source of both law and power. Apart from a Biblical perspective, the state becomes another god, and, **INSTEAD OF LAW, LEGALITY PREVAILS.**"²

Rushdoony points out that this devotion to legality has a long history in the modern world. As an example he cites Gohier, minister of justice in France during the Reign of Terror, and also Stalin, who operated his continuing terror under the umbrella of legality. Over the last several decades America has been gradually "legalized" and its people regimented into docile serfs under an all-powerful centralized government.

"But legality is not law," continues Rushdoony. "A state can, by strict legality, embark on a course of radical lawlessness. Legality has reference to the rules of the game as established by a state and its courts. Law has reference to fundamental God-given order. The modern state champions legality as a tool opposing law. The result is a legal destruction of law and order."

GOVERNMENT, A TERROR TO THE RIGHTEOUS

Yes, as a result, the state, instead of being a "terror" to evil-doers, progressively becomes a "terror" to the law-abiding citizenry to the righteous and godly people such as happening in America.

Vicious hoodlums, dangerous parolees, drug pushers, and Mafia gangsters, who should be behind bars or executed, apparently are free to terrorize the country with violence. But let a citizen insist on his right (not government privilege) to merely travel by motor vehicle on a roadway without a license, and the full force of enraged police power and the courts will, in the name of legalism, be unleashed upon him without mercy as was experienced recently by a Phoenix patriot-businessman who was jailed for the second time and brutally manhandled because he refuses to relinquish his right, as well as others.

A state that deserts its responsibility to administer justice, and thereby ceases to be a terror to evil-doers, and becomes, instead, a terror to the godly, is committing suicide.

WOE UNTO YOU SCRIBES AND PHARISEES

Throughout the history of the law profession, lawyers' esteem has been among the lowest of the professions, if not the lowest.



Lawyer - The case is coming along nicely; we're making rapid strides.

Client - That's what you told me four years ago; if we keep striding much longer I shall be barefoot before we get there. . .

Among the denunciations of lawyers over the centuries, the most scathing probably came from the lips of our Lord and Saviour, Jesus Christ, who addressed the scribes (lawyers) and Pharisees as hypocrites, blind guides, fools, killers of the prophets, serpents and vipers, (see Matthew 23).

As lawyers today make their living by taking something pure and simple and making it complicated and esoteric, so did their counterparts in Jesus' day. As Dr. Wm. Pascoe Goard said: "God through Moses gave us ten commandments. The Elders had multiplied them into 116 commandments"--plus myriads of related interpretations, rules, and teachings referred to by Jesus in Matthew 15:9 as the "commandments of men" (talmudic law) that were being taught in vain in place of pure doctrine. (For more on the Jewish Talmud, order **The Plot Against Christianity and Facts are Facts**).

The reputation of lawyers improved little in later centuries as attested by: Martin Luther in 1569-- "God has not given laws to make out of right wrong, and out of wrong right, as the unchristian lawyers do, who study law only for the sake of gain and profit."

William Wycherley 1674-- "A man without money needs no more fear a crowd of lawyers than a crowd of pickpockets."

Benjamin Franklin 1733-- "God works wonders now and then; Behold! a lawyer, an honest man."

A Russian proverb-- "When God wanted to chastise mankind He invented lawyers."⁴

In this present day, Robert Ringer had this to say in the "Ruff Times;" "I abhor generalizations. Fairness compels me to point



— My dear Sir, it is quite impossible for me to take on your case . . . You lack the most important piece of evidence . . . evidence that you can pay my fee! . . .

out that only 97% of the attorneys in the U.S. are lazy, incompetent, negligent, and greedy — yet they give the entire profession a bad name." ⁵

Christ did little to improve the profession's image with His statement:

"Woe be unto you lawyers! for ye took away the key of knowledge: ye entered not in yourselves, and them that were entering ye hindered." Luke 11:52

LAWYERS IN EARLY AMERICA

We turn to Robert McCurry's "Temple Times" for these sentiments of our early colonists:

"America's forefathers looked upon lawyers with great disdain. Lawyers were not allowed in the colony of Georgia because they were considered 'the pest and scourge of mankind.' ⁶ The colonies of Massachusetts Bay and Virginia banished and exiled lawyers because they considered them 'vermin,' 'devils,' 'treacherous,' 'destructive,' and 'parasites who feed on human misery wherever they go.' " ⁷

One good reason for these hostile feelings of the colonists is explained by Rushdoony:

"The Puritans of Massachusetts Bay Colony were fearful of the tendencies of English society towards a lawyer-order, and they began by banning a professional, paid lawyer-class. EVERY MAN HAD AN OBLIGATION TO KNOW THE LAW BY MEANS OF THE BIBLE." ⁸

The author explains that the state, not the church, required all Jury members to be believers and knowledgeable in God's law, not an esoteric doctrine that only a professional class could understand. When we look at the courts and jury system today we can see that this very thing has taken place. The juries have been convinced that the lawyer's law is

beyond their understanding and beyond their ability to judge the law (which besides being the very backbone of our free society, is their constitutional prerogative) therefore the judge must do the interpreting.

"The lawyer-order," continues author Rushdoony, "being alien to law, becomes a social order managed by social scientists. Since environment rather than sin is blamed for crime, treatment of the offenders... becomes the order of the day." ⁹

That crime victims have lost their lives, health and personal possessions is, apparently, of little consequence to the judicial system, but lawyer-law is quick to provide the Theodore Bundys with every possible convenience and legal loophole as they "vacation" in prison year after year at their victims' expense.

A MONSTROUS IDOL

When the lawyers turned from Biblical law to statist/statute/esoteric/humanistic law, a law-society was replaced by a lawyer-society. A monstrous idol was set up for all Americans to bow down to and obey. The day is coming when an enlightened and humble citizenry will cry out: "For the Lord is our judge, the Lord is our lawgiver, the Lord is our King; He will save us." (Isaiah 33:22) But in the meantime, the Lord declares:

"This evil people, which refuse to hear my words, which walk in the imagination of their heart, and walk after other gods, to serve them, and to worship them, shall even be as this girdle, which is good for nothing." (Jeremiah 13:10)

A GLUT OF LAWYERS

And what kind of blessings has our wonderful god-idol showered down upon us? Here are a few:

It has showered us with lawyers. Not just 20 or 30 thousand, enough to handle the necessary business of a nation this size—but 362,000 (as of 1978) of the pesky varmints. Chief Justice Warren Burger, himself, admitted "We may well be on our way to a society overrun by hordes of lawyers, hungry as locusts, and brigades of judges in numbers never before contemplated." ¹⁰

In tribal times, there were the medicine men. In the Middle Ages, there were the priests. Today, thanks to our benevolent god, there are the lawyers bringing us bountiful "blessings."

"It is the lawyers who run our civilization for us," writes Fred Rodell, former Professor of Law, Yale University. We have lawyers, he continues, "to run our governments our businesses, our private lives. Most legislators are lawyers; they make our laws. Most presidents, governors, commissioners, along with their advisors and brain-trusters are lawyers; they administer our laws."

"All the judges are lawyers; they interpret and enforce our laws. There is no



separation of powers where the lawyers are concerned. **THERE IS ONLY A CONCENTRATION OF ALL GOVERNMENT POWER--IN THE LAWYERS.** The whole elaborate structure of industry and finance is a lawyer-made house. We all live in it, but the lawyers run it."

Professor Rodell also reminds us that the lawyers are right there at our side in our private lives. Whether we buy a home, or rent an apartment, or get married or divorced they are there to guide us. We cannot die and leave our property to our children without our lawyer's advice to help us through a maze of confusing gestures and formalities using foreign language that is designed to baffle and befuddle the ordinary literate man untrained in legalese. "Speaking in tongues" is not necessarily restricted to the religious.

DO LAWYERS AFFECT THE G.N.P.?

We will conclude this commentary with these remarks, again from the "Temple Times":

"The more lawyers there are, the less business gets done. That's the conclusion of two University of Southern California economics professors who studied the growth rate of 52 nations. The link they found was that the countries producing lawyers don't produce a rising GNP, and countries producing don't produce lawyers.

"Possible reasons? First, lawyers exploit problems to create business. Second, lawyers spend their time making rules that require other lawyers to interpret, and third, lawyering is an unproductive diversion of a nation's talent." ¹¹

COMING SOON: MISSION IMPOSSIBLE

It is obvious that the whole Babylonish legal system (including the tax code) needs a thorough house cleaning, perhaps even a complete demolishing and rebuilding. At this point the only one capable of this "mission impossible" is the returning King of kings, Jesus Christ. According to the divine agenda, He is scheduled to perform this feat soon and with the same wrath, power, and authority as when He cleansed the temple of money-changers and iniquity. But this time the whole earth will shake and the rats will scamper.

We realize that some of our readers might be lawyers, or might have a lawyer friend, brother, or uncle whom they highly respect, and that they might resent this broadside against their profession.

We hope you understand that this is not a blanket indictment against all members of the profession. There are a handful of Christians out there who are lawyers--who are upright, conscientious lawyers (Robert Ringer's 3%?) who are refusing to partake in the immorality, dishonesty and deviousness that has for eons pervaded the legal system.

One such man was Co. James Hayes, who in the forward to the book, "Digest of the

Divine Law," said these words:

"After thousands of years of struggle along the lines of reform, the world has failed to find any system of ethics which can compare with that which is taught in the Sermon on the Mount..."

"In my experience as a lawyer, a judge, and a soldier, I have found the operation of human laws inadequate; and I have become convinced that the Divine Laws, set forth in the Bible, meet every need of man." ¹²

This is so true today. God's laws encompass the whole scope of human activities--personal relationships, government administration, jurisprudence, food, health, and so much more.

If the laws of God were adhered to by the earth's inhabitants, a Utopian Age would spring forth bringing benefits to mankind beyond his fondest and wildest dreams.

Man, in his spiritually rebellious state, may talk of freedom, liberty, and world peace as though through "democracy," a "constitution" or through other institutions of man he can legislate a paradise into existence whether he deserves it or not; but there can be no lasting freedom, liberty, or peace apart from THE DIVINE LAW of God in full operation. (We are not referring to the blood "ordinances" which were nailed to the cross).

Joshua 1:8 says, "This book of the law shall not depart out of thy mouth, but thou shalt meditate therein day and night, that thou mayest observe to do according to all that is written therein: for then thou shalt make thy way prosperous and thou shalt have good success."

Telephone taps

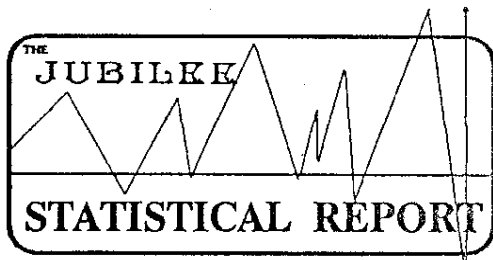
The United States Security Agency (NSA) is working with the English government to install an automatic monitoring system for use on all international and domestic telephone calls. The project is designated P145 and is now almost completed. This new Anglo-



American plan for global electronic spy system is far more extensive and sophisticated than originally planned. The system will be run by the GCHQ at Cheltenham, England. However, the equipment is located at an American base in Menwith, England. There will be four major surveillance activities to include: phone tapping as well as a system for long-range monitoring of radio signals and satellite communications.

This system, or one similar, is already in existence in the United States according to received reports. Pre-selected words are entered into their computer and when these words are said during a phone call, the recorders automatically record the conversation. Of course, all of this started out "for the defense of the west" but now can include "other" purposes. A documentary titled "Surveillance" was aired by HBO several years ago. It showed some of the exotic systems that are currently used and it was very revealing. *Shades of Orwell-1984!*

BIG BROTHER IN BACK SEAT

You might call it a guardian angel or say that it opens the flood gates to an Orwellian situation in which a computer records every movement you make in your car. Whatever you might happen to think of it, it is impossible to ignore a Melbourne invention called TIVARM. This electronic safety device demonstrates yet again the capacity of microchip technology to monitor and control everyday motoring.

Engineer Colin Power created TIVARM with the very best of intentions. It is designed to help cut down the road toll by keeping the driver fully informed about possible road problems and also allow traffic authorities to keep an eye on habitual speeding offenders.

TIVARM stands for Traffic Information Vehicle Automatic Recording Module and involves three components - road bar codes, an infra-red photoelectric cell mounted under the car and a microprocessor which displays information within the car. According to Colin Power, this complete road information system visually and audibly informs the driver of forthcoming road conditions and potential hazards. The hazards include speed limit changes, road flooding, underpass heights, and road accidents. The system also includes a disc facility to record the vehicle's speed, which traffic authorities could access on demand. Possible applications of this disc facility, he says, are in the young driver and multiple speed offender categories.

Colin Power adds: "To bar code all the main streets in a major city such as Melbourne (population 3 million) would cost about \$5 million. The price to fit out a car is around \$300." He says TIVARM has the potential to cut road fatalities by 20% and this would mean a saving of 1000 lives and over \$1 billion per year at present accident rates. He points out that 52,000 people have died on Australian roads since 1972 (80,000 were killed by aborti-



cide in ONE YEAR! Ed.) and that the road toll cost the community \$5.6 billion in 1987.

So far so good. Cost and other penalties are immaterial when it comes to safety and I trust the idea is a huge success in reducing accidents. But now let's look at the possible extensions of the basic theme, because some chilling concepts are already being tested overseas. The most obvious possibility is that once roads are bar-coded and linked with a central computer, big brother can look over every driver's shoulder always and continually.

Provided the car is electronically identified, it would be possible for the system to record automatically offences. Identification would be no problem because electronic number plates are already being tested in Hong Kong. The traffic offences they could monitor include exceeding the speed limit, crossing double lines, driving through a red signal or failing to stop at a halt sign. Even no-parking areas could be identified and electronically monitored. It would take a programmer little

me to arrange for the the computer not only to record the offence but spit out a traffic infringement notice automatically.

With very little extra effort, the computer could mail the fine and record the offence on the driver's "file" for review when the time comes to renew his or her driving license.

Obviously, any worries here mainly affect the bad guys, although there are times when even the good guys bend the law a little because of unusual conditions. A central computer is hardly likely to be as sympathetic as your local police officer if you explained that you were taking an emergency case to a hospital or stopped briefly in a no-park zone while you helped your frail and elderly aunt to catch the bus.

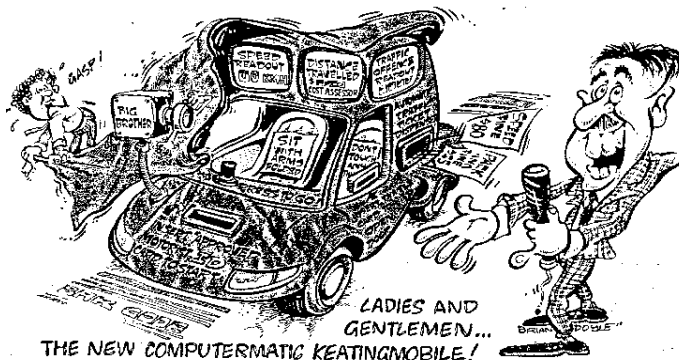
It is worth noting that once a computer is able to monitor a situation, it has the potential to control it. To this end, a car could be fitted with a type of cruise control system which ensures that it does not exceed the speed limit. It would be possible to have variable speed limits, which take into account the amount of traffic using the road, the weather conditions and even the type of vehicle involved. Once again, the traffic offenders would be most affected.

A much more worrying scenario comes about if the so-called "information explosion" reaches the state fund-raising coffers. Just as it is already feasible to monitor a driver's speed electronically, a central computer could keep tally of every kilometer a particular vehicle travels. Big Brother would know every time your car leaves the driveway and how far it travels. From here it is only a short step to the traffic authorities sending you an annual bill based on the distance travelled.

The argument possibly used to justify this approach is that a commercial traveller would pay for the privilege of driving long distances every day, while housewives save

because they use their cars only for occasional short trips. Once an automatic system of billing a vehicle owner for every kilometre driven has been established, a bar code under each road makes it possible for big brother to know where every vehicle goes and where it parks. Even the exact time and date could be recorded. You might be able to defend such an idea on the grounds that it would help the job of crime-busting - but the civil liberties implications are enormous. George Orwell, where is your push bike?

(Seems to me that the big road haulers and semi's might be the first to be on the receiving end of such totalitarianism! Ed.)

SURVEILLANCE

Several items of information have become available that tell us that the government is improving its ability to keep track of all citizens and to provide more comprehensive surveillance. The established news media released the information that a group of computer scientists have reported that the FBI has plans to expand its National Crime Information Center (NCIC) computer capability.

Currently, the computer, which is operated by the FBI, is available to all law enforcement agencies (they used to be termed "peace officers"). The country's law enforcement agencies have the capability of requesting the ownership of automobiles and trucks, and to determine if there are any outstanding warrants on the individual driving the vehicle. A driver's birthdate, social security number, address, name and driver's licence number are listed in the computer.

The news release said that the current plan for improvement of their computer system is a part of a larger blueprint to modernize the FBI's National Crime Information Centre (NCIC). There was no mention of why it is only a "part" of larger plans except to say that it is only a part of an "NCIC 2000" blueprint for updating the system. With the number "2000", it is possible that it is a part of the "Global 2000" plan, which was originated by the Club of Rome, the Trilateralists, and the CFR. The current upgrading efforts will include the capability to keep track of automobile drivers whether they are suspected of a



crime or not. For example, a person arrives in New York from abroad. The system would be notified when he passed through Customs. That means that Customs agents would automatically place data into the computer at their respective stations.

The system, at that time, would automatically notify the respective law enforcement agency that a "suspect" triggered the system. Then, if the person got a ticket somewhere on a road after he left the Customs agency, that information would also automatically be sent to the NCIC computer. In this way a person is "tracked."

Rep. Don Edwards of California is working with the computer scientists. "The files pose a potential threat to the privacy and civil liberties of persons included in the files and to the civil liberties of the public in general," they stated. "They pose too many problems in terms of security, privacy and accuracy, and it seems that the tracking proposals won't be very useful to law enforcement anyhow," Edwards said in a statement.

Apparently, the scientists nor Rep. Edwards don't realize just how the NCIC computer is used. Law enforcement officers all over the country simply ask the NCIC computer for information on vehicles whether the driver has done anything wrong or not. For example, whenever an officer sees an automobile from another state, that automobile is a candidate for the computer. When a patrol car is cruising through the parking lots of motels, those cars are candidates. If a person is dressed a little "scruffy", or has a funny looking beard, or for **any** reason, he is a candidate when he gets into his car. If a person from out of state is visiting a friend in a small town, he is a candidate for a NCIC check.

Does the technology exist to automate his surveillance in such a way that **all** automobiles could be "tracked" as they pass established checkpoints? The answer is a definite **yes**. Modern computer capacity exceeds by great margins the requirements for such a system. The communications capability is already in place. Could that be what NCIC 2000 means?

RETINAL SCANS

It has come to our attention that in Chicago the police are selecting, at random, tenants living in public housing to give them "retinal scans." This is a new technological identification process which scans and measures blood vessels at the back of one's eyes. The results are matched against identification records of the building occupants. It has also been reported that, within these same housing units, the area is surrounded, all exits sealed, water and electricity cut off, and apartments searched, without warrants or probable cause.

This is being done during drug investigations. We cannot deny that there are some awfully low-class people out there. At first blush, we want to say, "Go get-'em!" But then we must ask, "What do they do with them after they catch one or two?" If they receive a jail sentence at all, they often just learn how to be better criminals. I will promise you that there isn't a public whipping post in all of Chicago. The problem is that these activities will one day expand to all of the citizens, whether they are suspect or not. One can say, "No, that would never happen in the United States." But it is happening, with increasing intensity, right now.

Jesus said, *"And that servant, which knew his lord's will, and prepared not himself, neither did according to his will, shall be beaten with many stripes. But he that knew not, and did commit things worthy of stripes shall be beaten with few stripes. For unto whomsoever much is given, of him shall much be required: and to whom men have committed much, of him they will ask the more."* Luke 12:47-48.

AUSTRALIA - 1 Abortion for every 3 "live" births

The total number of Medicare-subsidised abortions in this country has increased from 61,773 in 1986/87 to 61,879 in 1987/88. Cost to the taxpayer? The Federal Government payout for Medicare-funded abortions amounted to \$6.4 million in 1987/88.

Social reasons account for more than 95 percent of the abortions obtained by American women according to a major survey by a leading pro-abortion organisation. She said 6.5 million abortions are performed annually in the Soviet Union. If these figures are accurate they would indicate that there are about 900,000 more abortions a year in the Soviet Union than live births.

HYPOCRITICAL GUILT

On one occasion, Otto Scott and I met a young man who lost no time in telling us of his burden of "guilt." His forefathers had been Southern slavers, dealing in the transport and sale of black slaves. We quickly gathered that he was a sensitive soul who wore his "guilt" as a badge of nobility.



On another trip, I was told of a young white woman, about 20 years old, who had been raped by a black hoodlum. She refused to report this crime, nor to tell her parents of it. Like her father and mother, she was a liberal. To report the rape, she felt, would confirm "a racial stereotype," and this she could not do. She spoke of understanding "the suppressed rage of the oppressed black men." She too was a "noble" soul who took upon herself the guilt of past generations.

Of course, all this is a false virtue which rests on a hypocritical guilt for past sins which they themselves did not commit. Neither of these two persons, nor others like them, feel any guilt for present sins in themselves. Instead, they claim a false nobility and virtue for their hypocritical guilt for the past of their people. As a student, I knew a wealthy young man who made clear that his father's business practices (whatever they were) were repugnant to him. This was his claim to a high moral ground. His immediate personal life was very bad, but he felt virtuous in condemning his father, whose money he used freely.

We have a new form of Phariseeism today which looks at the past and says, "I thank Thee, Lord, that I am not as one of those insensitive souls." When our Lord says, "Sufficient unto the day is the evil thereof" (Matt 6:34), He forbids us to borrow troubles (or guilt) from both the past and the future. To borrow either problems or guilt from the past or the future is ungodly.

Even more, guilt is personal. It has to do with one's own sins of commission or omission. To confess our parents' sins, or our ancestors' sins rather than our own is Phariseeism and a claim to being spiritually sensitive at their expense. It does not deal with one's own sins! (Sin = transgression of God's Law! 1 John 3:4, Ed.).

Some people feel very virtuous in "confessing" other people's sins. They are experts in correcting everyone around them. I regularly hear from such people about myself! Now, bad as that is, I believe it is even worse to confess our forefathers' sins and not our own. It is a violation of the law requiring us to honor our father and mother.

Paul speaks of some who have their "conscience seared with a hot iron" (1 Tim. 4:2), who claim a higher holiness than others. They refine their moral stance to give themselves a holier and higher way than others. To have one's conscience seared with a hot iron means to be insensitive to God, while sensitive to one's own will. It means that these insensitive people claim a higher sensitivity. Such people become adept at confessing other people's sins, and we see whites confessing black sins, blacks confessing the sins of whites, Orientals confessing Western sins, and so on. People love to catalogue the sins of other nations, of the United States, Japan, South Africa, Guatemala, Britain, and so on.

All of this means devaluing sin and changing its seriousness. It is routine now in much so-called evangelism to assure people that their sins are forgiven before they have admitted to or confessed sin. It is no wonder that such "converts" are routinely moral problems. Cheap forgiveness shows contempt for the cross. If our sin required Christ's atoning death, to treat sin and forgiveness lightly is a very serious offense against God's grace and mercy.

David understood the seriousness of sin and forgiveness. He wrote, "I acknowledge my transgressions: and my sin is ever before me. Against thee, thee only, have I sinned, and done this evil in thy sight" (Psalm 51:3-4).

Confessing other people's sin, the sin of our forefathers or the sin of our nation in the past, is a common evasion of responsibilities in the present. One women's club revels in hearing speakers who regale them with the sins of everyone outside their own "enlightened" circles. They know more "dirt," or fancied "dirt," about more people and groups than one can imagine! They are a happy lot of Pharisees who believe that they grow in virtue as they grow in their information about the sins of others!

Such Phariseeism is common on the right and on the left. It is very popular politics. It adds nothing, however, to the moral direction of society. All morality rests on a religious faith, and it results in action: no action, no morality.

Today, we have a world in which everybody seems eager to correct or regulate everyone else. Whenever a congress, legislature or parliament meets, it seeks more controls over others. (The U.S. Congress, as an accomplished body of Pharisees, routinely exempts itself from the laws it passes to bind all others!) This is Phariseeism, and it is evil.

Our Lord condemns Phariseeism above all else. He accused them of shutting up the Kingdom of Heaven by their warped teaching. He declares, "Ye shall receive the greater damnation" (Matt 23:24).

At the same time, our Lord **requires** us to seek **first** His Kingdom and righteousness (or, justice) (Matt 6:33); this is Christian reconstruction. The emphasis is on what the Lord would have us do, and it requires a faith with results, a faith which moves us to service and to faithfulness. When Paul was converted, his first words were, "Lord, what wilt Thou have me to do?" (Acts 9:6). He did not sit back to wait for heaven; he became a vineyard worker for the Lord. To be converted, to be regenerated, means to be made alive in Christ to serve and obey Him.

5. Thou Shalt Not Worry Or Be Anxious. "Be careful for nothing; but in everything by prayer and supplication with thanksgiving let your requests be made known unto Yahweh. And the peace of Yah, which passeth all understanding, shall keep your hearts and minds through eHoshua" (Phil 4:6-7).

6. Thou Shalt Not Fear Poverty And Lack Of Material Things. "But my Elohim shall supply all your needs according to His riches in glory by Yehoshua" (Phil 4:19). "Yahweh is my shepherd, I shall not want" (Psalm 23:1). "Beloved, I wish above all things that thou mayest prosper and be in health, even as thy soul prospereth" (3 John 2). 
