# VETERANS WARS: WHO ARE THEY GOOD FOR? by Ed Sommerville

There is hardly a week goes by that I don't get close to a dozen appeals from organizations to help veterans. These would include Disabled, Blinded, Paralyzed, Hospitalized etc. Over the years I have given thousands of dollars to these groups, as it is hard to realize what these men are going through. (I sometimes wonder how much of this money is actually going to the veterans) Some just boys out of high school and not knowing if their lives will ever get any better.

Today's troops are also faced with disabilities not attributed to enemy fire or explosives. Some are brought on by the vaccines and numerous shots that are forced on them. Others are subjected to depleted uranium that is used in our armor piercing shells. Just a small speck of this radioactive dust inhaled into the lungs will never go away. It causes permanent respiratory, as well as other serious problems.

Using this depleted uranium goes against the Geneva Convention on warfare, as it is radioactive and will remain there for a thousand generations. Many of the babies being born over there are born without arms and some are so deformed that I hesitate to even write about it. Much of this dust is moved around by the wind and some of it has been picked up and carried as far as England. If this war ever ends, it will not end for the people over there. We will also have to face the problems that result from our troops inhaling it.

There is an old saying: Old men start wars and young men fight them. This has never been as obvious as it is now. We are now involved in two wars with countries that have never done anything to threaten our freedom or safety (those countries are not threatening to vaccinate our children and grandchildren, and they are not coming here to confiscate your weapons-know your enemy!). In my lifetime we have never been involved in a war with any nation that could attack us and take away our freedom. As far as Pearl Harbour goes, was it a sneak attack? To our sailors and soldiers over there, it was. But to our President and his inner circle it was no surprise, and thanks to the Freedom of Information Act after 50 years of secrecy this has been confirmed by Naval Intelligence. This attack was used to get us into the war, as most of our people did not want another war in Europe. That is why 9/11 is referred to as the second Pearl Harbour, as it worked so well then. Although millions

are now aware of its cover-up, I think it could be years before we have a real investigation conducted by American patriots instead of politicians whose only purpose was and still is to conceal the truth and protect those involved in the greatest mass murder in our nation's history (an investigation may happen after all the perpetrators have died and cannot be held accountable anymore!)

One thing that really irritates me is when I read the many appeals for money is that they hardly ever fail to mention that our troops are over there fighting for our freedom and also fighting terrorism. Yet in my lifetime I have watched many of our freedoms disappear and be replaced with unjust laws, endless licenses, regulations and permits. Needless to say none of these were the result of an attack or war. As far as our being over there to kill terrorists, we could possibly be creating more of them than we are killing. There is one simple axiom that our people have never accepted. It is that Wars are never fought for the reasons we are told. Our present wars confirm this fact.

At the end of WWI General (Smedley) Butler was America's best loved and decorated soldier of that era. He wrote book entitled *War is a Racket*. In it he explains why in this famous quote:

"I spent 33 years and four months in active military service and dur-

ing that period I spent most of my time as a high class thug for Big Business, for Wall Street and the Bankers. In short, I was a racketeer, a gangster for capitalism. I helped make Mexico and especially Tampico safe for American oil interests in 1914. I helped make Haiti and Cuba a decent place for the National City Bank boys to collect revenues in. I helped in the raping of half a dozen Central American Republics for the benefit of Wall Street. I helped purify Nicaragua for the International Banking House of Brown Brothers in 1902-1912. I brought light to the Dominican Republic for the American sugar interests in 1916. I helped make Honduras right for the American fruit companies in 1903. In China in 1927 I helped see to it that Standard Oil went on its way unmolested. Looking back on it, I might have given Al Capone a few hints. The best he could do was to operate his racket in three districts. I operated on three continents."

General Butler turned against corporate America after he found out they were profiteering from their wars. Some of the major corporations made huge profits supplying the troops with needed commodities. Does this sound familiar?

We now have air bases in at least 130 countries with over 900 military bases worldwide. We don't need anywhere near that amount to maintain a more than adequate defense. Do you think there is a possibility that Corporate

America might have a use for them? The cost of these alone plus the billions it takes to maintain them is not justified for the greatest debtor nation on Earth. I feel that for the last few decades we have accelerated the business of empire building that cannot be in any way contributing to our national defense.

I always keep this in mind; **the first casualty of war is truth**. Propaganda is the greatest tool used to jump-start any war. There must always be a reason to start it so they come up with ideas that actually hide the real ones. The easiest one is to demonize a leader along with false

reports on what is happening there, since only a few know what the real reason is, as we are told only what their elite media wants us to know (and few are able to check the facts). Even when the truth comes out later it is quickly glossed over as the people including our veteran groups do not like the thought of us fighting a war for any other reasons than what we have been told. I don't think we are doing our veterans or troops a favor by giving them the false impression that any war we are involved in is a lawful, holy and just war and that God is on our side whatever we do or how many we kill and maim.

Our media constantly assures us that what we are doing over there is good no matter how many are killed on either side. They also like to convey the idea that anyone who disagrees with them is a terrorist and unpatriotic, like Jane Fonda or Abby Hoffman during the Vietnam era. I can assure you that many of us are the conservatives of yesteryear, not to be confused with the Neo-Cons of today. We are not as easily swayed by propaganda that has helped greatly in bringing about the problems we now face. We are no longer "The City on a Hill" that all the world looked up to as we have become an aggressive and war-like nation practicing torture on enemies, that many countries do not accept, coming from a "Christian Nation." This (undeclared) war like others has also brought about many broken marriages and fatherless children (which was part of the intention behind the war). All of our troops over there are not that happy about being a part of it as witnessed by the dramatic increase in suicides and drug use. No part of these (police action) wars are good for the average soldier, but they are great for corporate America.

One more thing I find very hard to accept: We have

spent over one trillion dollars on this war with billions unaccounted for and the private contractors along with the bankers and corporate America literally stealing billions for themselves and leaving people like myself to help the veterans. Am I out of line to think that these people who are getting filthy rich from the war that has given them so much, shouldn't think that they should give back to the veterans a small part to those who have given so much to their cause? Since our elected politicians can give hundreds of billions to our bankers why is it so impossible for them to take care of their troops? I'm sure that a few billion dollars would be a great help in eliminating a lot of the problems our troops face daily as the result of their war. As Ron Paul said, "Bring them home" I feel that is the best thing we can do for our troops and put an end to future pain and problems for our vets.

About a week ago I received a T-shirt in the mail from a veterans organization. On the front and back it said 'Proud to be an American.' First of all I would like to state that I feel very fortunate to have been born in America and raised in a Christian nation before it became Judeo-Chris-

tian. It was a time when we still had strong Christian values that were even prevalent in the public schools. Then the "destroyers" moved in and things started to change. In the sixties we went through a period of the drug culture and the morals that went along with it. Now we come to the point that we have murdered close to fifty million unborn children in the womb (while we hear endless stories of what Hitler supposedly did to Jews). #### THE BELIEVER IN JESUS AND DISASTERS

#### Supplies

There are many theories as to what will become of

banks, reserve bank systems, cash, etc., if there is a major recession. It is doubtful that there will be a total money crash unless the Banking System allows it, or engineers it. The time of traditional economics has passed, and in theory, the whole money system should have failed long ago. We are in the age of money manipulation and figures in computers are not real money.

The general feeling among those writing about and discussing the issue of preparedness seems to be that life after an economic disaster will be greatly enhanced by the ability to barter goods for goods. If you already produce

a surplus of food or other essential products, or are skilled in some essential service that everyone needs, then you may already be prepared for a system of barter. Also, many are advising that gold or silver coins represent a safer form of in which to keep savings than are cash and electronic transfer records. While gold and silver could always be traded for food and other necessities, gold together with fiat paper currency sometimes becomes essentially worthless. Have we not read something about a bag of gold not being able to buy a loaf of bread?

If you have no religious or biblical scruples against saving money in the bank, then there can be no reasonable objection to saving (additionally or instead) barterable commodities. Gold, silver, food and fuel are better than money in a crisis, but the latter two can be used in a practical way, whereas one would not get fat on trying to eat gold and silver! Values will only increase in a situation where everybody wants them and few have them. You can buy a year or more's supply of food packaged in air-tight, pest-proof containers which can either be eaten by your family or else bartered for toilet paper when the market shelves are bare. If there is no toilet paper, then a stock of old newspapers or books can could be torn up, especially at the library.

The great thing about turning your symbolic assets (money in the bank) into real goods is that you never have to regret your investment—even if the crisis never occurs. If there is no crisis in the years to come, then you will spend (as usual) a certain amount of money for groceries that year. What harm is done by taking the same money

and pre-buying the groceries for that year in air-tight buckets or drums? If we are talking about rice, wheat, beans, peas, salt, sugar, maybe some powdered milk, etc., these can be eaten by electric light or by candle light. I know that some of these precautions cost more money than many people have. Some families do not have enough money at this time to do many of the things I am suggesting. But I am hoping to raise your awareness of where the money you would normally spend on luxuries or entertainment might be better spent. A year's supply of plain, wholesome, packaged food might run you perhaps \$600 - \$1000 per person in the family. A basement accumulating these containers probably makes more sense than a family room with a new home theatre system. Perhaps a late-model car can be sold for the price of an older car and a year's supply of food for a family of six. The most painless way to accumulate a buffer food supply would be to simply buy a few extra cans of food every time you shop for groceries, and put the surplus aside for a rainy day (add the new items to the back of the line, and use the ones from the front of the line for stock rotation). When stores run sales involving deep price cuts on certain non-perishable items, it might be the time to pick-up a case or several extra gallons at significant sav-

Ask yourself what things you would wish to have on hand if there were no stores open for, say a month. You would probably wish to have a first aid kit, flashlight with batteries, extra toothpaste, soap and cleansers, contact lens solutions, any prescription drugs you might be dependent on, etc. Toilet paper has already been mentioned. It is advisable also to have some bottled water on hand for drinking, cooking and cleaning (use glass bottles rather than plastic). To be sure, a carton of matches would be of greater value than a bar of gold (or some good gas lighters) The thought of rubbing sticks together to light a fire might be too

much for some people.

Also, if you can back-up your home heating with wood heat (and or cooking - wood stove, or pot-belly stove). If wood heat is not an option where you live, you may want to put out the minimal investment for enough "space blankets" for the whole family. These extremely compact items, which look like a sheet of aluminium foil and retain an extraordinary percentage of your body's heat, can usually be purchased for pretty cheaply from many outdoor supply sources.

It also would make very good sense to obtain some way of generating electricity for basic uses. I'm sure that our readers are aware of various alternative energy options, such as wind generators, solar panels, and bicycle-driven generators—though a good old Coleman generator would prove more versatile and portable. If a family has more than one option available for electricity, it would make the adjustment to the loss of the power grid much smoother (Note: if you have solar panels that (also) feed into the grid, be aware that if there is no grid power, you also have no solar power! Only with a full off-grid battery back-up system will power continue)

At the midnight hour those who have not provided enough oil for their lamps might not find the merchants who sell oil open for business. It is better to have enough before hand. But remember that there are saints who barely survive on their meagre incomes already, and who have no ability to provide a buffer for their family against future cri-

ses. It would seem good for churches to develop (as Joseph did in Egypt) a food bank for their members who are unable to afford the luxury of surplus food storage. The ideal of Scripture is "Those who gathered much had no extra, and those who gathered little had no lack" (Ex. 15:18, 2 Cor 8:13-15).

#### **Circumstances Beyond Disaster**

Decisions with reference to some of the above options must be partially affected by consideration of precisely what kind of society can be expected to emerge from an end-time crisis. Will things get better quickly, or only after years of chaos—or will they get worse instead? What kind of challenges will be the post-crisis civilization present to Christian families? Will there be local government, federal government, world government—or what? Will society turn back to God, or further away from Him? Will Christians be sought out for their counsel—or for their heads? Will the worst problems for Christians be shortages of

food, marauding criminal gangs, or official government persecution? In my view, persecution for one's belief is certain (count on it after 'same-sex' "marriage" laws are passed!). Please note here that my use of the word "Christian" is used only in the sense of God's people who believe in the redemption that is in Jesus.

On the bright side, a technological cave-in might prevent the Prime Minister, President or anyone else, from being able to exert any control what-soever over the populace. Some 'experts' think that nothing broader than local or county gov-

ernment could function. They believe there will perhaps be seven to ten years of economic chaos, followed by a resemblance of the 1890s than that of the 2000s. This would mean the end of the Welfare State, of the Department of Education, or the Inland Revenue (Tax) Service or equivalent, and of all the grandiose Big Brother-esque plans of the New World Order. This is very encouraging. But is it what the future holds? Only time will tell.

There is still the threat of China and maverick nations or terrorists with nuclear weapons. If the NATO weapons systems go haywire, only the hand of God is powerful enough to prevent China or anyone else from pursuing an unstoppable course of aggression. China is said to have the Biblical number of 200,000 horsemen with the bows and arrows (British made) as we can read about in prophecy. I fully believe that the hand of God alone is more than adequate to protect God's people wherever they are from any designs anyone may have against us. But then we must ask why God would want to save people who have spit in His face and turned their back to Him. One might well reason that economic collapse is itself a form of God's judgment upon industrialized civilization (as are severe drastic weather conditions. which cause untold damage in terms of dollars, and even cost lives). History and Scripture portray a pattern of God's sending wave after wave of disaster upon nations upon whom He has decided to vent His wrath (e.g. Lev. 26:18, 21, 24, 28 and Isa. 5:25; 9:12, 17, 21; 10:4 and Eze. 26:3 and Rev. 9:12).

We must confess not to know for sure

- If there will be a crisis, or whether troubles will start in the near future.
  - How the matter will resolve itself, or if it will:
  - What society will look like a decade from now This ignorance should not paralyze us, but should lead

us to take precautions with the broadest spectrum of possible scenarios in mind, and leave the rest to God. The one thing that is certain is that God is faithful to those who cast themselves wholly upon Him and who do His bidding. One thing for sure is that slackness in knowing and doing God's Will is a luxury no one can afford. To be sure, God has not sent His warnings for no purpose. Our place is to believe God and act accordingly.

#### **Some Suggested Points for Prayer and Meditation**

The greatest form of preparation that parents can make for the safety of their families is to commit them to God and to commit all concerns to Him by believing, submissive prayer. It is possible to "have not" because we "ask not" (James 4:2). Some things may occur with or without our prayers, but if we neglect to pray, we will never know whether a given disaster might have been averted had we only prevailed to lay hold on God.

If Sodom had been spared, it would not have been so

much because of the ten (non-existent) righteous, but because of Abraham's intercession 18:23-33). If Abraham had prayed that God would spare the city for one righteous inhabitant, Sodom might have been spared to this day. We will never know, but it could have possibly postponed a gruesome judgment that came upon thousands of men, women and children. One reason that our world has come to its present crisis is, doubtless that "there is none that calleth upon [God's] name, that stirreth up himself to take hold of [God] for [He] hast hid [His] face from us,

and hast consumed us, because of our iniquities" (Isa. 64:7).

With reference to any indicated threat, what might informed Christians pray for? Let me make some suggestions. First, pray the prime (but seldom prayed with understanding) prayer that God's Kingdom come and His will be done. That God would send reformation of the church and a revival of pure Christianity is a request that can always be counted on to fall within the category of "things God wills." If the prayer of the apostles (Acts 4:23-30) serves as a model of appropriate prayer, then to pray for boldness, faithfulness and fruitfulness would take priority over prayer for personal safety, but there is nothing inappropriate about prayer for personal safety either (2 Thes. 3:2). Additionally, you might consider praying for the following:

- 1. That Christian families the world over might be spiritually prepared for whatever may come;
- 2. That Christian parents might not be separated from their children by "protective" governmental measures (e.g. vaccination)
- 3. That God would clearly inform Christian parents of any course of action that He knows will better prepare them for whatever He knows is coming.
- 4. That you and your children might be faithful even to death.
- 5. For kings, and for all that are in authority; that we may lead a quiet and peaceable life in all godliness and honesty. For this is good and acceptable in the sight of God our Saviour 1 Tim 2:2-3.

#### **Child Preparation**

On this final point, I should think it obvious that Christian parents make it their top priority to see to it that their children genuinely know God, and are prepared to meet the

Lord triumphantly, if they were to face mortal danger during their childhood years. I realize that such thoughts are unpleasant to parents, but what do you think Christian parents in persecuted lands teach their children? Do you think it can't happen here? And, happen very quickly!

When our children reached the age of being able to understand the English language, we made a point of acquainting them with the following, unfrightening facts:

- 1. It is God's good pleasure to raise us up into His Kingdom.
- 2. We will someday die, but this presents no terrors to those who love God.
- 3. To die in the will of God and to be taken into His presence is a great privilege to be looked forward to.

Since eternity is endless, and life is short, it doesn't matter whether we enter that eternal bliss after a "long" life, or after a relatively "short" life. All lives are short compared to eternity. Since we have no fear of death, and have re-enforced these truths to our children by scripture and by missionary/martyr biographies, our children do not exhibit any fear of death. I do believe that they are prepared for that inevitable, universal human event. for which only

neglectful parents would fail to

prepare their children.

However, we do not only wish to prepare our children to die, but also to survive and to live. Remember, if we do not provide for our children we are worse than infidels. We think it more valuable for them to know how to produce food and clothing and to function as redemptive parts of human society. In the education of our children, even if we foresaw no impending crisis, Christians ought to foresee the coming crisis of adult life as sufficient cause to weight their children's education heavily on the side of character strengths like courage, industry, integrity, compassion, humility and piety (not necessarily in that order). An education such as that commonly afforded in the modern educational system is more likely to prepare children to "make a living" than to "live." Children who are well taught in the latter will have little difficulty with the former. In fact, they will find that "all

these things" shall be added unto them, while they concentrate their energies upon the pursuit of God's Kingdom and His righteousness - Matt. 6:33. Those who know how to live find that making a living is thrown in with the deal.

If your children have become accustomed to a rather affluent standard of living, one of the biggest favours you can do them (whether there is a catastrophe or not) would be to wean them off such lifestyle expectations as soon as possible. Many Christian families, amazingly, have so pampered their children as to make it exceedingly difficult for them to be content "having food and raiment" - 1 Tim. 6:8. Though well-intentioned, parents who make materialists of their children, are doing them great spiritual harm, whereas those children who are taught early-on to "let your lifestyle be without covetousness, but be content with such things as you have" - Heb. 13:5-6, will be spiritually fitted for any circumstance that the future may hold (it's hard to teach these lessons to children unless the parents have

learned lessons themselves).

Teaching children to ignore their own denials and to have compassion on others who are suffering will render them of great value to God and to society. In any disaster, there will never be a surplus of selfless young people pouring themselves out for those less fortunate. Taking the children to rest homes to read to, talk to, or pray with the abandoned elderly, or having them do housework or gardening for some single mom in the church or the neighbourhood, will help develop this concern for others in your children today. It will serve them well—and humanity as well—to get their attention off themselves for a while.

#### Promises of God to the Faithful

Note the words, "the children" which are emphasized, meaning your physical children - not spiritual children.

"Observe and hear all these words which I command thee, that it may go well with thee, and with **THY children** after thee for ever, when thou doest that which is good and right in the sight of the Lord thy God." Deuteronomy 12:28.

"But thus saith the Lord, Even the captives of the mighty shall be taken away, and the prey of the terrible shall be

delivered: for I will contend with him that contendeth with thee, and I will save THY children." Isaiah 49:25.

"Fear thou not: for I am with thee: be not dismayed; for I am thy God. I will strengthen thee; yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness." Isaiah 41:10.


"And all thy children shall be taught of the Lord, and great shall be the peace of **THY children**." Isa. 54:13.

## WHY DID FDR PROVOKE JAPAN TO ATTACK AMERICA?

These actions have been well-documented elsewhere—termination of trade treaties, embargoes of material and the like. The big blow was the oil embargo.

His military advisors were strongly against the embargo, rightly anticipating that this would lead to war with Japan. Yet Roosevelt went ahead with the embargo in the summer of 1941—abruptly reversing his prior position. At the same time, he took other measures within days of the embargo decision: freezing Japan's U.S. assets, breaking off diplomatic talks with Japan, and arming the Philippines.

Something happened at this time to get Roosevelt to change so abruptly and go against his military advisors. Victor cites historian Waldo Heinrichs with a "unique idea." Roosevelt changed his attitude about pressuring Japan in order to save the Soviet Union. Germany had just invaded Russia, and Japan was contemplating when and how to support its German ally. Roosevelt was aware of these Japanese deliberations and preparations—Japan would make war plans for both the Soviet Union and the United States, but would only fight one of them. Victor believes it is quite credible that Roosevelt abruptly changed his

approach and became more provocative with Japan for the purpose of reducing the risk that Japan attacks the Soviet's."

I don't know about you, but in all my study of WWII information, I had never heard that "unique idea" before. To me this idea makes total sense when you understand that FDR wanted the Soviet Union as our ally even though it was a communist nation. Sadly, the author of the book is a strong supporter of FDR in spite of this type of information.

#### THE INCREDIBLE DISAPPEARING MAN

Of course you all know of Alksandr Solzhenitsyn. Who doesn't? Legendary Russian dissident during the Soviet era, prisoner in the gulags, starved, tortured, ostracized. But never broken. He spoke truth to power like few have ever done. His novels such as *The Gulag Archipelago*, *The First Circle* and *Cancer Ward* were not only brilliant literature but offered the rarest of insights into the life of a dissident in the USSR. He came to be regarded as one of the most eminent writers and philosophers of his age, which contributed to his being awarded the Nobel Prize for Literature in 1970 "for ethical force with which he has pursued the indispensable traditions of Russian literature."

Feted wherever he went, his books became international best-sellers, translated into dozens of languages, the world was at his feet. Then almost overnight it all stopped. He became a non-person. The transformation was virtually unprecedented in the field of literature. Why did this happen? Because Alex stepped on the Third Rail. Well, he didn't so much step on it, rather dived on it full length. You see he wrote a book called **200 Years Together** that traced the Jews' colourful relationship with the Russian people and especially their role in the Bolshevik Revolution and its murderous tyranny.

He didn't pull his punches. He placed Soviet Jews centre place in perpetrating the worst mass murders of the 20th century. While acknowledging that some Jews also suffered under this tyranny he clarified that it was not as Jews *per* 



se, rather that they were in the wrong faction at the wrong time. Solzhenitsyn's own estimate for the number of Christians (his word) who died was 60 million. He documented all of this in meticulous detail ... names, dates, times. But he did something else, something more insidious and dangerous. Something that had strategic international consequences for the Tribe. For a start he shone a light on the extraordinary Jewish capacity to magic themselves into a position of victimhood irrespective of their actual accountability. This in turn depended on — as he pointedly noted — their uncanny ability to seize control of media outlets. "There are pages of this history which one does not open without trembling. And these are the pages that are systematically and purposefully eradicated from the consciousness of the Jews."

Other observations that cut to the bone included their practice of manipulating the legal framework to reflect Jewish interests (think "hate" legislation). I haven't even begun to describe what he wrote in 200 Years Together not least because I haven't read it, only certain chapters. So why have I not read it? Aha, therein lies a tale! You see, Solzhenitsyn's legendary status and guarantee of vast sales would in normal circumstances have had international publishers slavering at the prospect of getting their hands on the rights

getting their hands on the rights. But none did. None wanted it. It was never published in the West. In fact, incredible as it seems it has never been formally translated into English (Where's Victor Marsden when you need him?)! Given that English translations exist for almost every half-assed writing in the most obscure of languages the disappearance of 200 Years Together is mind-blowing. The author himself became a non-person as he had in the USSR.

Think about it. It is, as I said, mind-blowing. What sort of pressure could have resulted in every Western publishing house, every Western TV company, every Western magazine being intimidated into passing up such a unique and hugely profitable publishing coup? How exactly was this Jewish power exercised? Was it overt, subtle, physical, financial..... or what? It truly is frightening.

#### MOVING THE ANCIENT BOUNDARIES

"Do not move the ancient landmark that your fathers have set." Proverbs 22:28.

Mankind has always been faced with a choice: either accept God's terms (and His definitions of terms), or construct independent and self-serving ones. When a culture constructs new ways of referring to Biblical concepts, it is evidence that it is in active rebellion against God and its laws and conduct will reflect such rebellion. When the peo-

ple of God succumb to altered definitions and modern adjustments to God's Word, the results are detrimental and decidedly wicked. What's more, issues that are clearcut in the Bible and clearly defined in Scripture become muddled and unnecessarily complex.

In the law of God as given to Moses and fulfilled (put into force) by Jesus, certain behaviours are deemed capital offences. This means that God requires the death penalty to be imposed by the civil government on people who commit those crimes. In addition to the justice demanded by God for these crimes, the death penalty also purges evil from among the people. Yet in our day and age, due to antinomian compromise within the church and outright humanism in the secular world, we have replaced

Biblical terms with euphemistic ones and compounded the problem by inserting the concept of "mitigating circumstances" to areas where the Scripture speaks plainly and clearly.

An example of this is the term "fornication." In Scripture this refers to and umbrellas many sexual behaviours that are outside the bounds of godly, covenant marriage between and man and a woman. R.J. Rushdoony notes:

"In proverbs, all extra-marital sexuality is condemned, and the counsels concerning the evils of prostitution, adultery, and pre-marital sexuality are all given as age-old wisdom and implicit in God's Law. Marital chastity is declared to be the standard (Prov. 5:1-23). It is presented, not as an impoverishing life, but as a well-spring of joy and health to man's being." I

Some like to posit a different set of rules under the New Covenant. There is no Biblical basis for this antinomian perspective.

"The New Testament forbad all non-marital sexual intercourse, and pre-marital relations therefore as well, without any concern other than to restate the Biblical Law for Greek and Roman converts (Acts 15:20, 29; 21:25; Rom. 1:29, 1 Cor 5:1; 6:13, 18; 7:2). Jesus forbad the thoughts leading to it (Matt. 5:28).

Clearly then, Biblical Law is designed to create a familistic society, and the central social offense is to strike at the life of the family. Adultery is thus placed on the same level as murder, in that it is a murderous act against the central social institution of a healthy culture."<sup>2</sup>

As adultery requires the death penalty under God's Law, so too do other specific acts of fornication: rape, homosexuality, and incest. But today these transgressions of the law are given euphemisms in our modern culture. Adultery is sanitized to "having an affair." Rape has lost much of its meaning due to promiscuity being the norm rather than the exception [nowadays usually referred to as "sexual assault"], not to mention how in some circles, any act of sex between a man and a woman is deemed rape depending on the mindset of the woman.<sup>3</sup> And, words such as "gay" and "queer" have replaced the term homosexual that is used in Scripture. Parents or parent-figures are said to have molested or abused their children—terms not found in Scripture—rather than having committed incest with them and by extension adultery against their spouse if they are married. Add to this the societal conditioning, where perjury is expected, yet rarely prosecuted, not to mention

that the death penalty is all but extinct (but required for perjury in a capital crime case, as well). Is it any wonder that within and without the church there seems to be no end of the reports of gross sexual misconduct? In truth, the people of God often prove helpless in separating the fact from the fiction and have no inkling as to how to apply God's Law to these situations.

Martin Selbrede notes that for certain transgressions of God's Law (covered under the term "abuse"), "Any number more than zero is one too many."4 He states:

"There are as many kinds of abuse as there are sinful impulses in the heart of man. Physical, emotional, spiritual, sexual, and ecclesiastical abuse must never be depersonalised or smeared with the vocabulary of collusion. Where abuse has in fact occurred, it must be dealt with in a godly way. Ezekiel 34 can help us grasp the manifold facets of such abuse and harm that can be inflicted on one or more sheep ...

If we fail to take God's oath seriously, and move to retain individuals in capacities where the harm they inflicted can be repeated, we will have placed ourselves firmly on the side of injustice. Small wonder that the modern church is filled with the walking wounded ... Deut 16:20 reads "Justice, justice shalt thou do," not "Injustice, injustice shalt thou preserve and protect."5

Since the operative nature of God's Law is ignored by most people and churches, and is not customarily the subject of Sunday sermons, it is easy to let standards other than Biblical ones rule the day. Uninformed or partially informed comments on social media often determine the guilt or innocence of the accused or accuser. Emotionalism and slander replace solid Biblical thinking. Even those who claim to adhere to theonomic principles are likely to abandon them in order to spare themselves or their congregations embarrassment or condemnation.

If we are serious about wanting to protect children, women, and society from sexual predators, we need to teach children (at home and in church) from the earliest age what God has to say on the subject of lawful sexuality. Some will protest that this instruction will sexualize children prematurely, but failing to teach them leaves them fair game for perpetrators and aggressors. Better that they become acquainted with these matters from those who will provide instruction from a thoroughly Biblical perspective, than from someone without the same interest and concern

It is always preferable to provide instruction before problems arise when the terms and context of the teaching can be done calmly and systematically. Those whose families have been ravaged by sexual violations often agree with this statement in hindsight. Although the following examples are hardly of the same magnitude of teaching children how to obey God in the area of sexuality, they illustrate the point that we regularly address the reality of potentially negative outcomes as we prepare our children for scenarios they may encounter.

• When a family is planning a wilderness vacation or a simple hike, instruction is given to children to be on the lookout for poison ivy and poison oak. The plants are described and they are schooled in how to spot them before they are standing in the midst of them. One could argue that by pointing these out to children ahead of time they will go and seek out the plants and play there. However, by calling their attention to the hazards posed by even touching them, unnecessary pain and suffering can be avoided.

• When teaching young people to drive, we encourage the concept of defensive driving. By demonstrating the

> devastating effects of collision injuries or even death, and encouraging the frequent and proper use of mirrors, speed limits, and safe driving practices, we help a new driver maneuver through the hazards associated with getting behind the wheel. Rarely do these precautions dissuade the teen from driving altogether. Just the opposite is the case. The person is better equipped to deal with the inevitable challenges that will be faced each time they

#### WHILE THEIR HEARTS ARE **TENDER**

Very young children are often the target of sexual predators (both

within and without the church). Their trusting natures and their eagerness to please give an advantage to those who see to harm them. We do not have to "toughen" the tender hearts of children to prevent them from becoming victims. We can speak to their tender hearts as we teach God's rules and show that God's laws are operative even for children. So, as we instruct children on modesty (not running around without clothes on), and respecting the personal spaces and bodies of others (not solving their differences by coming to blows), we can also teach that because of God's high premium on marriage and fidelity, care must be taken to remain in His will long before a person is ready for mar-

Discussing why we cover certain parts of our body and guard our chastity is a way sin (the opposite of godliness) and its effects can be explained to children. If you teach them when they are young, they have the principle in place before they experience temptation in these areas. If they understand that mommy and daddy have an exclusive relationship with each other that does not include other people, and that the same rules apply to them even before they marry, red flags will go up if something contrary to Biblical teaching if offered to them.

Because of the epidemic of adults fornicating with children, it is important that we refine our terms so that gullible children are not fooled by "friendly" people who come bearing treats or presents. The familiar admonition, "Don't talk with strangers," implies that the only true threats come from people they don't know. However, once someone has been introduced and seen on a regular basis, the designation of stranger no longer applies. Instead, children should be told that secrecy from their parents is never an acceptable condition when dealing with others. Someone who wishes to take advantage of children will usually encourage secrecy and instruct them not to speak to others about any

of what takes place. Whether they are seduced by pleasure or intimidated by fear, if children have not been prepared to recognize a sinful situation, defend themselves, and report it to their parents, then their vulnerability is a direct result of parental negligence, at best.

In the devastating scenario of a parent abusing his or her own son or daughter, the non-offending parent must remember that Biblically the responsibility and loyalty is first and foremost to God, and then to protect the child. Attempting to handle revelations of sexual misconduct privately and without outside assistance compounds the problem and makes discovering the truth or falsity of the claim additionally difficult.

Biblical definitions and Biblical consequences must be taught and understood if we hope to bring light to this very dark area. We must use the Biblical terms for these specific acts of fornication: adultery, incest, rape, and homosexuality. Trying to soften these terms only serves to lessen the fact that the acts are primarily offenses against God, and

that His Word contains the consequences for so doing.

Among the problems attendant with this entire subject is the absence of Biblical terms to replace the concepts of abuse and molestation. As we've moved away from Biblical definitions, the waters get muddier and muddier. Moreover, some want to dismiss any allegation corroborating witnesses.<sup>6</sup> While it is true that it takes wisdom to adjudicate in these matters, without people who place God's Law above personal considerations or public opinion, we don't have a fighting chance.

The Bible is not silent regarding those who don't have corroborating witnesses to sexual offenses perpetrated against them. Psalm 10:2-11 describes the plea of the oppressed person. Most definitely, those who are victimized by the sexual aggression of others fall into the category of the oppressed. Note how well the psalmist describes the actions of the wicked as they go after the

weak and helpless.

"2 In arrogance the wicked hotly pursue the poor; let them be caught in the schemes that they have devised. 3 For the wicked boasts of the desires of his soul, and the one greedy for gain curses and renounces the Lord. 4 In the pride of his face the wicked does not seek him; all his thoughts are, 'There is no God.' 5 His ways prosper at all times; your judgments are on high, out of his sight; as for his foes, he puffs at them. 6 He says in his heart, 'I shall not be moved; throughout all generations I shall not meet adversity.' 7 His mouth is filled with cursing and deceit and oppression; under his tongue are mischief and iniquity.

8 He sits in ambush in the villages; in hiding places he murders the innocent. His eyes stealthily watch for the helpless; 9 he lurks in ambush like a lion in his thicket; he lurks that he may seize the poor when he draws him into his net. 10 The helpless are crushed, sink down, and fall by his might. 11 He says in his heart, 'God has forgotten, he has hidden his face, he will never see it.'

#### PROPER JURISDICTION

Failing to acquaint children with the tactics and strategies of those who might oppress them leaves them at a decided disadvantage when it comes to protection. We must insist that our children tell us immediately of anything untoward that happens to them. This policy protects both the accused and the accuser so that steps can be taken to investigate the matter and bring in the civil authorities to help adjudicate the truth or falsehoods of the claims. Anything less subverts justice (one way or the other) and creates a shadow-world of secrecy.

Some object to calling in civil authorities, stating that the ungodly status quo disqualifies the civil realm from dealing with such accusations and crimes. This argument fails on many counts, not the least of which is the Godgiven jurisdiction for justice God gives to the state. If we are going to call into question instances of overreach by one institution into the affairs of others (health, education, and welfare), we must uphold the proper duties of the civil magistrate.

Others call it a matter for the church to deal with. This. again, fails because the church does not wield the sword and for this reason must bring in the civil authorities to determine whether allegations of sexual violation have

> occurred. The church has the power of excommunication, which may be in order for the offender, but that in and of itself does not bring about justice for the offended. We must make proper use of the institution God has ordained to deal with such matters, even if it exercises its role imperfectly. This should be the impetus for God's people to work toward the Christian reconstruction of society so that we end up with a godly civil realm.8

#### LIABILITY OF THE **BYSTANDER**

Along with training children to be forthright with their parents (or another adult in the case of an offending parent), the person who becomes aware of the situation of sexual violation has a responsibility to aid the afflicted. Rushdoony notes:

"This principle of responsibility appears in Deuteronomy 22:24. A woman assaulted in a city is presumed to have given consent if she does not raise a cry, the origin of the hue and cry common law. At her cry, every man within sound of her voice has a duty to render immediate aid; failure to do so was regarded as a a fearful abomination which polluted the land, and figuratively, darkened the sun."9

Not unlike in the parable of the Good Samaritan, we must render aid when we are approached by an oppressed or afflicted person. We cannot fall back on the fact that we're too busy or we are uncertain as to the truth or falsity of the claim. We are not to be a bystander to the situation, but must help to bring about justice. Again Rushdoony

"The civil legal situation may be an equivocal one; the biblical legal requirement is not. Misprision, i.e. the concealment of a crime, is a serious offense. The inactive bystander is a party to the crime. The parable of the Good Samaritan (Luke 10:29-37) was firmly based on biblical law.

In the parable of the Good Samaritan, the priest and the Levite avoided the victim and "passed by on the other side." The religious leaders claimed to obey the law; they tithed "mint and rue and all manner of herbs, and pass over judgment and the love of God" (Luke 11:42). It was an easy matter to tithe mint; it sometimes required moral courage to help a victim; in the case of the victim Jesus described, not even courage was required, only assistance in terms of the law to a victim abandoned by the criminals. The religious leaders kept the law only when it cost them little or nothing to do so. Jesus confounded them from the law.

It is thus a serious error to reduce the parable of the Good Samaritan to the level of feeling alone, or to a matter of charity; these things are subordinate to the law in this case. Those who despise the law are also without charity. They profess to love the law, but they choose simple



matters for obedience and despise the things which are difficult. Too many churchmen today reduce the law to simple rules about the sabbath and adultery and bypass or violate the rest of the law with impunity. This is Pharisaism."  $^{10}$ 

Although no one enjoys conflict, there are times when unpleasant accusations need to be dealt with scripturally. Unless the people of God adhere to God's Word in the area of sexuality, they will not be able to deal with the ugly situations that a wicked and perverse generation presents us with. We represent Jesus the Anointed as Christians and need to understand that the psalmist is calling *us* to insist on justice—justice on God's terms.

"O Lord, you hear the desire of the afflicted; you will strengthen their heart; you will incline your ear to do justice to the fatherless and the oppressed, so that man who is of the earth may strike terror no more." (Psalm 10:17-18).\*\*\*\*\*

#### THINK BEFORE YOU INK

Recently I watched a news clip about Dr. Jon Mendelsohn at Advanced Cosmetic Surgery and Laser Center. He was using his skills as a plastic surgeon to remove unwanted tattoos from convicted criminals who had just been released from prison. It's a mission he hopes will help these men live better lives.

Two of his clients, Michael and Leroy, have served

time behind bars. Michael was sentenced on drug charges. Leroy's criminal record began when he was 12. Now 31, he's been locked up for more years than he's been free. Leroy realized that the tattoos made it harder for him to get a job.

Both former convicts are now fathers, and they realized that to get a job they had to remove the tattoos. They also wanted to be a better example to their children, so now they are having them removed.

We often make our decisions on the spur of the moment, based on our emotions at the time or peer pressure, instead of considering how this will affect us down the road or how it will look on our changing bodies. Will this person whose name I want to tattoo on me be in my life 20 years from now?

In making a decision, consider how you will feel about it years later. Here are three factors to think about in considering a decision, particularly when it comes to tattoos.

#### Will You Regret the Decision Later?

The number of people who regret getting tattoos while a

teen or a young adult is on the rise, according to a survey reported in London's Daily Mail (Naomi Greenaway, "Do You Regret Your Tattoo? One in Six People Hate Theirs and 50% Regret Getting Inked Because It Makes Them Look Common," April 1, 2014).

The article noted that "one in six hate their tattoos so much they want them surgically removed" and that "the most prevalent reason for the change of heart is fear of the so-called 'tramp stamps,' as fifty percent worry they will be

considered 'common [and] uncultured.""

What seemed so cool years ago is not so cool for them now. Even several well-known celebrities claim they now regret their tattoos. More than a third of those surveyed "express regret for fear of how they'll look as they get older (and saggier), and half of those surveyed admitted that a person with prominent tattoos was less likely to succeed in business."

The article also noted the following: "Perceived promiscuity is also a worry for the tattooed masses. One in six of those surveyed said people with tattoos are seen as more likely to have one-night-stands."

Three celebrity music artists who are judges in the weekly television singing competition show *The Voice* have regrets of being inked. In 2012 Pharrell Williams told **Complex** magazine that he was "young and dumb" when he got his tattoos and is currently going through the painful process of having them removed.

Adam Levine can't stand the tattoo on his right shoulder that was supposed to be a cool Russian heritage symbol. Instead he now thinks it looks more like a "cauliflower with a sun in the middle of it."

Blake Shelton, another judge on The Voice, considers his tattoo of deer tracks—which he got to represent his love of hunting—ugly and stupid, mostly because the tracks are "constantly mistaken for lady bugs." All three now have regrets. So ask yourself, Will I regret it later? Will it be worth the cost and pain to remove it?

How Will It Affect The Image You Want to Present?

What image do markings on your body reflect to others? How might it affect your job and career? How might it affect your children? According to an article titled: "How Tattoos Affect Your Career" at Salary.com, a survey of

2,700 people found that 76 percent felt that tattoos and piercings hurt an applicant's chances of being hired for a job. Dr. Andrew Timming of St. Andrews University School of Management interviewed recruiters in 14 organizations, including a hotel, bank, city council, prison, university and bookseller, to get a broad view of their opinions on tattoos. He found that most respondents agreed that visible tattoos are a stigma.

And think about this: While you might think it's cool to have a tattoo, the most surprising finding of the survey reported in the *Daily Mail* earlier is that when it comes to romance, a tattoo can be a turn-off—even to people who have them! A third of those surveyed said they would be less likely to date someone with prominent tattoos.

So ask yourself: What kind of image do I want to project? Will this affect me in job hunting or my plans for my

future career? And will my tattoos be a turn-off in regards to courting and future relationships?

#### **Does It Glorify God?**

Above all, will your decision whether to sport a tattoo reflect God and His values and character? We need to remember that He is holy and pure and wants us to be also. God commanded His nation of Israel, "You shall not make any cuttings in your flesh for the dead, nor tattoo any marks on you; I am the Lord" (Leviticus 19:28).

The Apostle Paul reminds us that our body is meant to be the temple of God holy spirit and that it does not belong to us but was bought at the price of Jesus' blood when He died for us, so we are to glorify God in our body (1 Cor. 6:19-20). Whatever we do should reflect and glorify Him.

Is your body consistent with the importance you attach to your life as God's creation and the intended dwelling place of His spirit? We are to represent God (Matthew 5:14; 1 Peter 2:9, 12). Our worship of and service to Him are far more important than anything else we do. Do we give others that distinct impression by our appearance, or do we send a very different message?

While we strive with God's help to be clean and pure on the inside, this should affect how we present ourselves on the outside. Will you be a good representative for God's way of life starting with your appearance? Or when people see you coming, will they be turned off?

Think therefore before you decide to tattoo your body. A vital key to making wise decisions is to consider the *consequences*! Every single decision you have ever made or will ever make has consequences, whether good or bad. Don't follow the crowd! Have courage to be your own person and be proud of it! You can do that without having to tattoo your body.

Ask yourself these three crucial questions: Will you regret the decision later? How will it affect the image you want to present? Does it glorify God - or disobey His Law?

If you already got one or more tattoos before now, you shouldn't feel like you have to have them removed to have a deep relationship with God (although they should be covered or removed if they promote something offensive, vulgar or demonic). You are very special to God and the person you are on the inside is what most concerns Him.

This article is aimed at those who might be thinking about getting tattoos now or in the future, and isn't meant to condemn those who already have them. More broadly it is aimed at all young people who read this in hope that they will think before they ink!

#### CHINA HAS MORE SUBS THAN U.S. NAVY

China's Navy now has a submarine fleet larger than that of the United States, a U.S. admiral said on February 25. "Their submarine force has grown over a tremendous rate," Vice Adm. Joseph Mulloy told the House Armed Service Committee's Seapower and Projection Forces Subcommittee. "They now have more diesel and nuclear attack submarines than we have, so they've passed us in total quantity."

The U.S. Navy has 71 commissioned submarines, and experts say China's fleet now numbers at least in the low 70s, though the precise number is unpublished and the quality of the submarines is known to be inferior. However, that is changing.

"They are producing some fairly amazing submarines,"

Mulloy said. "They've now had three deployments in the Indian Ocean. They are expanding where their submarines go. We know they are out experimenting and working and operating and certainly want to be in the world of advanced submarines."

As Beijing's military buil-up continues and the nation develops strong ties with oil-rich Russia, watch for smaller Asian nations to rally around this Asian hegemon.

#### GIMME THAT OLD-TIME RELIGION
