ITS DANGEROUS TO BE RIGHT by pastor Mark Downey

"Blessed are ye, when men shall revile you, and persecute you, and shall say all manner of evil against you falsely, for my sake ... Rejoice, and be exceeding glad for great is your reward in heaven: for so persecuted they the prophets which were before you." Matthew 5:11-12.

If you're an Identity Christian old enough to remember the 'right-wing-extremist' musician Carl Klang, he had a song called, "It's Dangerous to be Right, When the Government is Wrong." If you're really old, you probably remember who Carl got his title from: Voltaire is reputed to have said, "It is dangerous to be right in matters on which the established authorities are wrong." Some versions say "established men." Any viewpoint that questions, contradicts or opposes the views maintained and propagated by those who have established themselves as the ruling power are perceived as a threat to their authority and if left unchecked, the prevailing belief of society will replace it with something else. Sometimes this process takes centuries and other times, the established law and order takes drastic measures to silence the opposition in short order. Many times it turns into all out war. In more recent times, armed conflicts are contrived, what is called a false flag operation. Orwell observed that, "In a time of universal deceit, telling the truth is a revolutionary act." Those who are so bold to expose corruption, blow the whistle to turn our attention to evil-doers. History has enough examples of rulers taking extreme measures by killing people with persuasive new ideas or rekindling old ideas that have a ring of goodness to them or just making common sense. Just ask Galileo. If someone discovers a cure for cancer that is cheap and effective (and they have), do you think the American Cancer Society (ACS) is going to lead an army of lobbyists to the Legislators? They've had ample opportunities to do so since their founding in 1913; wow! The same year the Federal Reserve Bank was founded. Do you think there's a connection?

I said that facetiously, but when I did a search with those two entries, I was flabbergasted with page after page of white collar executives whose resumes did connect with the Fed and the ACS, which is a combination of the AMA monopoly/Big Pharma and insurance companies. It all translates into the cash cow that Jews have been milking for over a hundred years. If somebody has the time to research this Babylonian connection, it may lead to some very interesting liaisons, that some researchers have already touched upon. There is an aristocracy of the rich in America even

though our founders were leery of 'titles of nobility.' This singular point was made convincingly with John Perkins in his runaway bestseller "Confessions of an Economic Hit Man." (see CI-397 @ \$17).

According to Perkins, he began writing this book in the 1980s, but "threats and bribes always convinced him to stop." Perkins function was to convince the political and financial leadership of under-developed countries to accept enormous development loans from institutions like the World Bank and USAID. Saddled with debts they could not hope to pay, those countries were forced to acquiesce to political pressure from the United States on a variety of issues. Perkins argues in his book that developing nations were effectively neutralized politically, had the gap between upper and lower classes driven wider and economies crippled in the long run. In this capacity, Perkins recounts his meetings with some prominent individuals. Perkins describes the role of an economic hit man as follows: Economic hit men (EHMs) are highly paid professionals who cheat countries around the globe out of trillions of dollars. They funnel money from the World Bank and the US Agency of International Development (USAID),

and other foreign "aid" organizations into the coffers of huge corporations and the pockets of a few wealthy families who control the planet's natural resources. Their tools included fraudulent financial reports, rigged elections, payoffs, extortion, sex, and murder. They play a game as old as empire, but one that has taken on a new and terrifying dimension during this time of globalization. Of course the media has their brothel of whores who describe Perkins as "a frothing conspiracy theorist, a vainglorious peddler of nonsense." Perhaps the JFK assassination has its most astute sharpshooters mocking theories that come really close to 'whodunit.' It's dangerous to expose murderers.

For those with eyes to see, this wicked manipulation of money and people is described in many places throughout the Bible. physician. "He said to them, They that be whole need not a physician, but they that are sick" (Matt. 9:12). Our nation is sick with sin and we need the Great Physician, not AMA quacks. ish, you can be called an anti-Semite and in the old USSR anti-Semitism was punishable by death. It is a mentality war, in which the mind of Jesus (the anointed mind) will not be altered by things God never meant for man to consume. A lot of people misunderstand Mt. 15:11, "It is not what enters into the mouth that defiles the man, but what proceeds out of the mouth, this defiles the man" to justify that they can eat anything, but Peter still didn't get the parable, so Jesus explained in verse 17, that every food deemed clean by God is processed in the stomach and eliminated through the excretionary system. ditions - all who want to join in community to live in relationship with God and be of service to people. Shalom! Pastor Wolfgang Stahlberg, a member of the Progressive [communist?] Christian Alliance of Colorado." The problem with all that is that the God of the Bible will have no relationship with such blatant blasphemies that are in His face, rubbing the Lord's nose in the idols of Baal. Aside from embracing evolution, they claim to "seek justice, peace and inclusion for all creation." Their church picnics must resemble a circus freak show. It's dangerous to not be a progressive universalist, when the

church allows the bastard, the sodomite, the communist globalist and barnyard creatures to enter the congregation, justice for pigs, let the swine enter the sanctuary; peace for the vultures and roadkill critters .. come on down for the altar call

ministry, because of the arrogance of authority in the priestcraft, which became symbiotic to the political demands of Judea and Rome. As the Lord's reputation increased, many became more hostile towards Him. Even His followers were falling by the wayside. "Because of what Jesus said, many from among His disciples [students] quit following Him and no longer walked with Him" John 6:66. I think that's very similar to the parable of the sower; some of the seeds were devoured by fowls (i.e. the wicked), some fell on stony ground (i.e. hardened hearts), some fell among thorns and were choked (i.e. mongrelization or universalism); but some of the seed fell on fertile ground and became fruitful (i.e. our people being convicted of their sins and repenting and thus following Jesus). They became more God-fearing than fearing anything man or government could do to them, because Jesus gave them hope. Hope is the only thing stronger than fear. A little hope is effective; a lot of hope is dangerous. It's dangerous to stand your ground when it is fertile and growing and healthy. There's nothing like a clear mind that is focused and Jesuscentered. The corrupt government of America is part of Mystery Babylon and wallows in confusion: we are treated

like mushrooms, kept in the dark and fed manure. It's dangerous for the UNITED STATES GOVERN-MENT INC. to be wrong, when the people are right. Most Americans do not believe Lee Harvey Oswald was the lone assassin; most Americans believe 9/11 was an inside job; most Americans believe something is wrong with the government, but they don't know who is right.

I often refer to TV newsmen as media whores, because they are paid to lie to the public and to form public opinion. In a way, they play God by being the Potter and we the clay. I have already alluded to the shoddy journalism about health and vaccinations. It is dangerous to expose prefabricated stories about an imminent disease turning into a hysterical pandemic and the only saviors in sight are unelected experts saying "Hi, I'm from the Center for Disease Control and I'm here to help you, please cooperate

with our quarantine and imposed treatment." If you ask these doctors, who are ready to stick a needle in your arm with some mysterious serum, what it is made from? And they can't tell you, but you know that it contains awful ingredients that a witch's brew would be proud of: mercury, formaldehyde, aspartame, aluminium, monkey puss, and aborted foetus material, etc. Did you know that mercury is the second most poisonous element known to man? And more and more people are learning the facts, which are denied and mocked, just like they did with cigarettes, and their pillar of reality begins to crumble and collapse. THE GENESIS RECORD

The record of Noah's day referred to by Jesus is found in Genesis 6.

"And it came to pass, when men began to multiply on the face of the earth, and daughters were born unto them, that the sons of God (Adam's descendants) saw the daughters of men that they were fair; and they took them wives of all which they chose. And the Lord said, My spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years. There were mighty men in the

earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown. And God saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually. And it grieved him at his heart. And the Lord said, I will destroy man whom I have created from the face of the earth; both man and beast, and the creeping thing, and the fowls of the air; for it repenteth me that I have made them" (Gen. 6:1-7).

There were fewer than two thousand years between the first and sixth chapter of Genesis (there were 1656 years between creation of Adam and the flood). There were only two Adamic seeds on the earth. First, there was the seed of Cain who had been banished by God and excluded from the covenant blessing because he had rejected God's orderly way of obedience and worship and murdered his brother Abel (Gen. 4:15-16). Interestingly Cain's genealogy (Gen. 4:17-24) is not a part of Adam's genealogy (Gen. 5:1-32). Second, there was the Godly, covenant seed of Seth. The "daughters of men" were Cain's seed line and the "sons of God" were Seth's seed line.

By the time of Noah, however, marriage had lost its sacredness and permanence. Divorce and remarriage were rampant. God's ordained orderly way of marriage became so violated that the earth was filled with violence (much like today??)(Gen. 6:11,13).



God's Ordained and Orderly Way of Marriage

God created Adam and Eve at the same time. Eve was created *in* Adam (Gen 2:26-28). God took Eve *out* of the side of Adam and builded a woman and presented her to Adam (Gen 2:18, 21-24). They were *one flesh*. It was Adam and Eve not Adam and Steve. God made no spares for Adam and Eve in the event they later decided, for whatever reason, they wanted to dissolve the marriage and go their separate ways. There were no disillusion clauses in this marriage. It was one man for one woman and one woman for one man. It was a marriage "until death do us part." This was God's ideal original building block for marriage.

But in less than two thousand years man had abandoned God's ideal original building block and marriage was perverted and in shambles. They were "marrying and giving in marriage." Marriage, divorce, and remarriage were a revolving door. As a result of the breakdown of marriage and the family, the earth was "filled with violence" (Gen. 6:11,13). They eventually passed the point of no return. God's ideal original building block had been so per-

verted and broken that God in essence said, "I've had enough. I'm not going to repair this mess. I'm going to destroy the whole earth." And He did. But not until after Noah, a righteous man, preached repentance for one hundred and twenty years. The people refused to hear, believe, and repent. One day God shut the door to the ark, and a world that refused to listen didn't even know what happened "until the flood came and took them all away" (matt. 24:39).

It's about to happen again.

The Message of Jesus concerning divorce and remarriage, Jesus said, "It hath been said, Whosoever shall put away his wife, let him give her a writing of divorcement: But I say unto you, That whosoever shall put away his wife, saving for the cause of fornication, causeth her to commit adultery: and whosoever shall marry her that is put away committeth adultery" (Matt. 5:31-32). (for more on the subject of divorce and remarriage, see the booklets by Ted Weiland, Bob Hallstrom, and Stephen Jones, #244 @ \$9.25; #813 @ \$8.25; and #436 @ \$7.25)

God does not say that He hates divorced people, but God does say that He hates divorce. The problems arise when the translators do not differentiate between "put away" and "bill of divorce".

"Yet ye say, Wherefore? Because the Lord hath been

"Yet ye say, Wherefore? Because the Lord hath been witness between thee and the wife of thy youth, against whom thou hast dealt treacherously: yet is she thy companion, and the wife of thy covenant. And did not he make one? Yet had he the residue of the spirit. And wherefore one? That he might seek a godly seed. Therefore take heed to your spirit, and let none deal treacherously against the wife of his youth. For the Lord, the God of Israel, saith that he hateth putting away (parting without divorce): for one covereth violence with his garment, saith the Lord of hosts: therefore take heed to your spirit, that ye deal not treacherously. Ye have wearied the Lord with your words. Yet ye say, Wherein have we wearied him? When ye say, Every one that doeth evil is good in the sight of the Lord, and he delighteth in them; or Where is the God of judgment?" (Mal. 2:14-17).

Paul said, "For I am jealous over you with godly jeal-

ousy: for I have espoused you to one husband, that I may present you as a chaste virgin to The Anointed" (2 Cor. 11:2). Note: The bride is to be a "chaste virgin" - a maiden; by implication, an unmarried daughter. The bride as a pure virgin saves her love for one man only, for the one who will be her husband.

Every participant and attendee at a Christian marriage ceremony is a confirming and approving witness that the marriage ceremony they are witnessing truly reflects the biblical symbolic image of Jesus and His Ecclesia. Therefore, a Christian's participation in or attendance at a marriage ceremony that misrepresents and mars this biblical symbolic criterion of Jesus and His Ecclesia dishonors Jesus.

The public Christian marriage ceremony is a sacred ceremony. It is here that the groom and bride exchange covenantal promises with one another and make vows to God that is to continue "until death do us part." God says of the marriage relationship, "Wherefore they are no more twain, but one flesh. What therefore God has joined together, let not man put asunder" (Matt 16:6). It is clear. A

subsequent divorce disqualifies them from another public Christian marriage ceremony.

Unfortunately, some Christian do end their marriage in divorce, and the majority of divorced Christians remarry. Thankfully, many Christians that remarry after divorce understand that there are certain restrictions that follow divorce and they do not, therefore, expect a public Christian marriage ceremony. There are marriage ceremony options available to those who choose

Cleaving and putting asunder

The word cleave means to glue, to stick, to adhere firmly and closely or loyally and unwaveringly. The word implies permanence. The word asunder means all to pieces, one part from the other, to shred. To put asunder is to tear. The same Greek word for asunder is used in Acts 1:18, "Now this man [Judas] purchased a field with the reward of iniquity; and falling headlong, he burst asunder in the midst, and all his bowels gushed out."

It is God that joins together in marriage. The two are one flesh. It is impossible to *separate* one flesh. But it is possible for one flesh to be *torn*, *cut* and *broken asunder* by divorce. It is God that commands that marriage not be put asunder - torn, cut, or broken apart. Divorce hurts, but it does more than hurt. It causes anguish, anger, animosity, and bitterness in the spirit and emotions of the spouses, children, extended families, and friends. Divorce is one tragedy that is worse than death. It never ends.

Marriage, divorce, remarriage, and violence

There are ever-increasing reports of meaningless, senseless violence wreaking havoc in every segment of our society. This writer has observed that most perpetrators of this violence are products of divorce. More and more adults are walking the treadmill of divorce and remarriage, some multiple times. Many divorced people are merely shacking-up. Children and teenagers are either living in a single-parent home (single as the result of divorce) or living in a home with a step-parent. But the violence that makes news merely serves as a cover for the mass of unreported violence.

The violence in Noah's day was caused by interracial



marriage, divorce and remarriage. Divorce and remarriage, children out of wedlock, is the root cause of most of today's anguish, anger, animosity, bitterness, and violence.

Churches and Weddings

Pastors and churches have long served as guardians of the sacred institution of marriage. They have so served by ascertaining that weddings performed under their auspices and direction meet the Biblical criteria and properly represent the image of Jesus and His Ecclesia. For example, neither bride nor groom is divorced; both bride and groom are Christians with credible testimonies; all activities including music, ceremony, and reception are in keeping with God's Word and orderly way.

Until recently, Bible-believing pastors were so committed to the integrity and permanence of marriage that they would not perform a wedding for divorced persons—publicly or privately. Pastors and churches would never partici-

pate in a church wedding if they knew the couple had been cohabiting, the bride was pregnant, the bride had birthed children outside of marriage, or the groom had fathered children outside of marriage. But those are yesterday's standards. More and more pastors and churches today are abandoning the old paths and church weddings have few, if any, restrictions. How sad. Many would only marry people from their own congregations, who were known to them, and not marry outsiders. Why this departure from God's Word and orderly way? One word tells it all: Accommodation.

Church weddings involving divorced people are a recent phenomenon. Of course, there is no verse in the Bible that says: "Divorced people cannot get married in a church building." But neither is there a verse in the Bible that says, "Sodomites cannot get married in a church building." Unfortunately, sodomites are now demanding their "rights" and an increasing number of pastors are performing "same-sex marriages" in churches. The Georgia Southern Baptist Convention withdrew fellowship from two Southern Baptist churches in 1998 for performing and/or sanctioning such 'marriages.' Yes, many things have changed in many churches in recent years in order to accommodate the whims and lusts of today's people—a people who do what is right in their own eyes. But God's Word has not changed, and it will not change.

When the Bible talks about "church" it is not talking about a building or denomination; it is referring to the Ecclesia that Jesus purchased with His blood. This 'Church' consists of Jesus' redeemed people in a local visible assembly of people of which Jesus the Christ is Lord and Head. Although there were no church buildings for over one hundred years after the resurrection of Jesus, the Lord's Congregation did assemble to worship and study God's Word (hence the mention of "forsaking to assemble" as some were wont to do). Today the Lord's Congregation meets to worship in buildings that are called "churches." But in reality these "church buildings" are not "churches"—they are merely "church buildings" that have been dedicated as a place for the Lord's Congregation to assemble.

Today, a "church-building" is synonymous with the Lord's Church, God, and the Bible in the minds of many people. Therefore, whatever message is proclaimed and whatever activities are carried on in a church building—including weddings—represent God and the Bible in their minds. Of course, it is true that the message pro-

claimed and the activities carried on in a church building may not truly represent God and the Bible. Nevertheless, it is true that the message proclaimed and the activities carried on in a church building *do* represent and portray what the Congregation believes, approves, sanctions, promotes, and recommends that other people believe, approve, sanction, promote, and practice. It used to be that when people went to the church building, they saw that as entering into the presence of God, and required dress, seating, and behaviour in an appropriate orderly and reverent manner while there.

Responding to the crisis

All of the teachings of God's Word on marriage, putting away, divorce, and remarriage notwithstanding, it is a fact that an ever increasing number of people, including Christians, are divorcing and remarrying. Sadly, some are now divorcing and remarrying multiple times (following

the trend of Hollywood). Among the many factors contributing to this divorce epidemic are: Neglect by the Congregation in scripturally preaching and teaching on the subject of putting away, divorce and remarriage, and, "no-fault" divorce laws in all states. Some are now considering the repeal of these "no-fault" laws and indicate they will be replaced with tougher and more restrictive divorce laws.

Only the Lord's Congregation can provide the truth and solution to the rapidly increasing divorce epidemic. But this will happen only when the Congregation and Chris-

tians choose to agree with God about divorce. God hates putting asunder, and we must hate what God hates. The sin of divorce must be acknowledged, confessed, repented of, and forsaken. Of course, God will forgive the sin of divorce if and when the terms of His Word are met.

The past cannot be relived and, generally speaking, the past can not be changed. And let's face it. The combined efforts of the Congregation and the legislature will never completely eliminate divorce under the best of circumstances. But since divorce is first and foremost a spiritual issue and not principally a legal problem, the Church must provide the leadership to stop the hemorrhaging and minimize the damages of divorce in the future.

Christians, who have divorced and/or divorced and remarried are not offended by, nor do they object to and resent Scriptural teaching on these subjects, if they have truly dealt with the subject in obedience to God's Word. Rather, they will joyfully accept such preaching as a springboard of praise and rejoicing that God has extended His grace and forgiveness to them,

Old Paths and Old Landmarks

What I have set forth here has been the historic teaching and practice of Bible-believing pastors, churches and the Christian Community at large until recent times. It is what I was taught by my pastors. It is what I was taught in Bible school. It is what I have taught and preached during my sixty-four years of Gospel ministry, including what I taught, preached, and practiced during my more than fifty years as pastor of the same church.

It was not until recent times that some preachers and churches began departing from God's Word and orderly way on the subject of divorce and remarriage. 'BECAUSE I SAID SO'

Scientists treat dissent like heresy. But considering their track record, they should welcome debate.

What should be done to those who question the belief that human activity is causing catastrophic global climate change?

Environmental activist Robert F. Kennedy Jr. (nephew of the late president) recently said some of such people are "treasonous" and should be in jail with other criminals. Similarly, climatologist James Hansen, who was NASA's

top climate expert for over a decade, said questioners of the hypothesis should face criminal trial for "high crimes against humanity." For Richard Parncutt, a professor at the University of Graz in Austria, however, prison is not punishment enough. In 2012, he said: "I propose that the death penalty is appropriate for influential GW (Global Warming) deniers." [What? get out the Zyklon B?]

More mainstream activists generally don't call for prison or execution, but still work to silence all questioners. In 2007,

The Weather Channel's climate guru called for stripping certification from unbelieving meteorologists. A Senate report that year showed that unconvinced scientists routinely faced threats and intimidation by proponents. In 2013, Reddit's/r/science forum—which, with five times more subscribers than the New York Times, has become the front line of science-public interface—banned climate change questioners from discussions and said newspapers should follow its lead. A few months later, in his State of the Union address, US President Barack Obama said that "climate change is a fact" and "the debate is settled."

This desire to silence, imprison or even kill opposition raises specific questions about climate change. It also raises broad questions applicable to all of science.

Why is Climate Alarmism Questioned?

The main reason some question the belief that human activity is causing catastrophic climate change is that some of the science behind the hypothesis is thin—to put it mildly.

Historic evidence shows that Earth's climate has always warmed and cooled—sometimes abruptly. Most of these changes came long before the Industrial Age. Little evidence supports the notion that current fluctuations are unordinary. Prof. R. Timothy Patterson, director of the Ottawa-Carleton Geoscience Center at Carleton University, wrote: "Climate stability has never been a feature of planet Earth." The world's climate "changes continually and, at times, quite rapidly," he wrote. "Many times in the past, temperatures were far higher than today, and occasionally, temperatures were colder. As recently as 6,000 years ago, it was about 3°C warmer than now. Ten thousand years ago, while the world was coming out of the thousand-year-log

'Younger Dryas' cold episode, temperatures rose as much as 6°C in a decade—100 times faster than the past century's 0.6°C warming that has so upset environmentalists' (*National Post*, June 20, 2007).

Another thin part of the anthropogenic global warming (AGW) hypothesis lies in claims that rising CO_2 levels from human activity drive up the atmosphere's temperature in a clear instance of cause-and-effect. Such experts as geophysicist and retired astronaut Walter Cunningham say this claim is faulty because temperature increases have often come before boosts in CO_2 levels. "We cannot be sure which is cause and which is effect," he wrote in the July-August 2008 issue of *Launch*. "Historically, temperature increases have preceded high CO_2 levels, and there have been periods when atmosphere CO_2 levels were as much as 16 times what they are now, periods characterized not by warming but by glaciation."

Ian Plimer, professor of Mining Geology at the University of Adelaide, South Australia, also questions the link

between CO₂ and temperature. In his book *Heaven and Earth: Global Warming, The Missing Science*, he shows that from 1860 to 1875, temperatures went up. They then fell from 1875 to 1890, increased until 1903, then fell again until 1918. From 1918 to 1941, they sharply rose—then cooled again until 1976. CO₂ emissions were much lower at the start of the 20th century than they are now. So why were the amount and rates of warming greater then? Why is the Arctic now cooler than

it was in the 1920s and 1930s, when carbon emissions were much lower?

From 2000 to 2010, mankind added about 110 billion tons of CO₂ to the atmosphere. That's more than a quarter of the total since the start of the Industrial Revolution in 1750. Yet, during that decade, there was no statistically significant increase in global temperatures.

Also problematic is the AGW claim that carbon dioxide is a toxic, "industrial" gas that is having a catastrophic effect on the climate. CO₂ is a natural, trace gas that currently constitutes just 4 one-hundredths of 1 percent of the planet's atmosphere—far less than during other epochs. "At the current level of 400 parts per million, we still live in a CO₂-starved world," says *Climate Change Reconsidered II*, a report written in 2013 by a team of 50 scientists on the Nongovernmental International Panel on Climate Change (NIPCC). "Atmospheric levels (of CO₂) 15 times greater existed during the pre-Cambrian period (about 550 million years ago) without known adverse effects," the report says.

Atmospheric scientist Robert L. Scotto says green activists also overstate mankind's contribution to CO₂ levels, and understate that of the sun: "Based on the laws of physics, the effect on temperature of man's contribution to atmospheric CO₂ levels is miniscule and indiscernible from the natural variability caused in large part by changes in solar energy output." The fact that Mars, Pluto and Jupiter—upon which there are no carbon emitting factories—are currently heating up strengthen the view that the sun is largely responsible. Man's CO₂ emissions are also paltry compared to the amount released into the atmosphere by vegetation and the oceans.

Moreover, carbon dioxide is actually vital to life on the planet. "CO₂ is a vital nutrient used by plants in photo-

synthesis," the NIPCC report stated. "Increasing CO₂ in the atmosphere 'greens' the planet and helps feed the growing human population."

Do these points resolve the controversy? Do they mean mankind's CO₂ emissions are not potentially dangerous? Do they mean no further study into climate change is needed?

No. They do not settle the questions or close the book. They are among many issues that have not been examined to the satisfaction of Patterson, Plimer, Cunningham, Scotto, the NIPCC and a rapidly growing counter movement

Why So Many Scandals?

Another reason some question the hypothesis of catastrophic climate change is that many of its lead advocates have been rocked by serious scandals.

In 2009, thousands of documents were leaked from the University of East Anglia Climatic Research Unit (CRU). They revealed years of data manipulation, suppression and fraud by prominent climate scientists. The massive scandal,

nicknamed Climategate, revealed three main themes: First, many scientists privately admit to each other that parts of the data are flimsy and require manipulation if they are to support the idea of severe man-made climate change. Second, many leading climate scientists see climate change as more of a political cause than a scientific pursuit. Third, many such scientists hide underlying data if it does not support the cause.

If the science is sure and settled, why would this manipulation

and anti-scientific behaviour be needed to "prove" it? Climategate has been called "the worst scandal of this generation" and "the biggest scam in history." Yet it was downplayed by climate activists and whitewashed or ignored by most media and politicians. Most activists call the revelations "irrelevant."

But are they irrelevant? In one leaked e-mail, climatologist Kevin Trenberth wrote: "The fact is that we can't account for the lack of warming at the moment and it is a travesty that we can't." In another, CRU chief P.D. Jones wrote to climatologists Michael Mann, Raymond Bradley and Malcolm Hughes: "I've just completed Mike's nature trick of adding the real temps to each series for the last 20 years (i.e. from 1981 onwards) ... to hide the decline."

It was the use of this "trick" that had enabled Mann to produce the now infamous "hockey stick" graph. Gathering data from ice cores, tree rings, lake sediments and corals, his crew graphed global temperature over the past thousand years. Their graph showed a long, mostly flat line for the years from 800 to 1900 (the handle of the hockey stick), then a sudden upward spike (the upturned blade). It seemed to pin warming firmly on industrialization and became a fixture of global warming alarmism.

But the problem is that the graph was the result of manipulation—or, as Jones said, a "trick." Mann had massaged the data to get rid of a pesky time of pre-industrial warmth called the Medieval Warm Period that occurred from about AD 1000 to 1300. Just after this period came the Little Ice Age, which lasted until late 1800s. Does this mean 20th century warming could be largely a natural recovery from those cold years? Mann's trick, which buried around seven centuries of climate history, tries to silence such questions.

In 2011, Climategate 2.0 broke. A new batch of 5,000

e-mails was leaked to the public showing the same themes as the first batch. "I have been talking w/folks in the states about finding an investigative journalist to investigate and expose [skeptical scientist Steve McIntyre]," wrote Mann in one leaked e-mail. "The trick may be to decide on the main message and use that to guide what's included and what is left out [of IPCC reports]," wrote Jonathan Overpeck, coordinating lead author for the most recent climate assessment by the United Nations Intergovernmental Panel on Climate Change (IPCC), in another.

Then there is the famous "97 percent consensus" figure—one of the most frequently cited arguments of climate alarmists: Let's not get into looking at the facts; those are established; 97 percent of all scientists agree. That number comes from a group led by John Cook that claims to have analyzed almost 12,000 peer-reviewed climate studies to find that 97 percent of them endorsed the view that humans are causing severe global climate change.

But shortly after Cook's meta-study was published, investigative journalists at *Popular Technology* produced evidence showing that his crew had doctored the results by

misclassifying many "skeptic" papers as consensus papers, cherry-picking data and asking misleading questions. Popular Technology asked many of the scientists whose studies Cook had lumped in with the "consensus" if that representation of their work was accurate. Here are a few of the replies: "Nope .. it is not an accurate representation." "That is not an accurate representation of my paper." "It would be incorrect to claim that our paper was an

endorsement of CO₂-induced global warming." "Cook et al. (2013) is based on a straw man argument ... What my papers say is that ... 40-70 percent of the global warming observed from 1900 to 2000 was induced by the sun. "Certainly not correct and certainly misleading."

The "97 percent" claim also ignores 60 scientists who published a document in 2006 lambasting the theory of AGW. And it ignores the international panel of more than 700 prominent scientists on the December 2007 Senate report. This group of climatologists, geologists, oceanographers, biologists, glaciologists, biogeographers, meteorologists, economists, chemists, environmental scientists, physicists, paleo-climatologists and other scientists signed a letter saying climate change was a well-known natural phenomenon. Many of them were current or former members of the IPCC.

Yet the "97 percent consensus" remains a mantra of climate change activists, while the Popular Technology piece, the 2006 document and the 2007 Senate report go largely ignored.

Climate change was delivered its most recent black eye in January 2015, just after all the jubilant claims by alarmists that 2014 had been "the hottest year on record." One of the key regions warming especially fast was a large swath of South America. Researcher Paul Homewood compared the published temperatures that were originally recorded. In all three cases, he found the data had been doctored to show warming where there actually was none. Homewood then turned his attention to the weather stations between Canada and the heart of Siberia. Again, in almost every case, he discovered that the same one-way upward temperature adjustments had been made. The Telegraph said this "fiddling with temperature data" wasn't just the biggest of all climate change scandals, but "the biggest science scandal ever" (February 7).

It seems that the more the climate data is scrutinized, the more doctoring, manipulation and data massaging is exposed.

Why Is It Blasphemy to Ouestion?

When the thin science is placed alongside the scandals, and then considered in light of the fanatic efforts to silence questioners, a worrying picture emerges: Belief in climate change has departed from science and become something more like a religious faith.

It bears all the hallmarks of a man-made religion: a caste of priests and prophets, an irrational set of beliefs which adherents cling to tenaciously, abuse of authority and intimidation of any dissent. It even has plenty of sacred

When believers are confronted with evidence that disproves or questions their dogma — like, for example, the study published in March 2013 showing that global temperatures had been static for 15 years even though greenhousegas emissions during that time had soared—it only seems to strengthen their piety. The "persecution" fortifies their

resolve. Many adherents seem driven by a faith just as blind as that in some religionists they are

so quick to criticize.

"True believers," Cunningham said, "are beyond being interested in evidence: it is impossible to reason [people] out of positions they have not been reasoned into.'

Do calls for investigating and exposing skeptics sound like objective scientists, or like Puritans who ran the Salem witch hunts? Do demands to suppress

heresy sound like unbiased researchers, or like religious extremists? Do suggestions to execute deniers sound like experts motivated by reason, or like the cries of Catholic Church leaders during the Inquisitions?

Clearly, such calls and demands do not sound like the voice of science. "Science is facts," said French physicist Henri Poincare, and "just as houses are made of stones, so science is made of facts.'

That means science is apolitical and welcomes prodding, scrutiny and debate. Its focus is on measurable, pressure-tested evidence. Its love is not for religious dogma, but for facts. Its goal is not to prove a hypothesis, but to test it in order to see whether it is true or untrue. It is not arrogantly confident, but humbly aware of its limitations. Since science is concerned, not with courting agendas but with discovering truth, scientists are unbiased, transparent, objective, and receptive to criticism and investigation.

The climate change debate is being dominated not by scientists, but by pseudo-scientist ideology-driven zealots. They approach it backward, with a conclusion firmly in mind. Whatever they can contort into supporting the hypothesis, they keep. All else they often reject or downplay. They facts are made submissive to the conclusion.

And climate change is not the only topic that has been thusly hijacked. In the world of academia, there is one person who is more ridiculed, blackballed and ostracized than a climate skeptic: a questioner of the theory of evolution.

'Science Falsely So-Called'

Long before the climate change hypothesis or the evolutionary theory were hatched, the Apostle Paul labeled such agenda-based movements "science falsely so called" (1 Tim. 6:20).

These movements expose the fallibility of science. Does this mean we should give science the cold shoulder?



Not at all. The problem isn't with science, but with man's misuse of it. The Creator God authored true science, and the means for men and women to love and pursue it. Question: What does CI mean when it talks about Christ coming back to save us? Does CI believe, as some Christians do, that we lie in the ground after death waiting for a "judgment day" when we are either brought back to life or discarded? CI people speak of a non material world, do they mean spirit world? If so, surely the "judgment" is ongoing now, so Jesus coming back, only applies to this world?

Greetings: The things that you ask are a bit of a mixed bag of things based most likely on what poses as CI. I guess CI should be seen as any group that sees our identity with the folk of the Bible. But CI is not a church organization or cult as it has no central bishop system.

So there will be many using the term CI but the thing to remember is that many of the folk who have come out of some church or another and thus have teaching from whence they came but with a layer of 'identity' over the top of it, much like BI, which are chiefly ex-Anglicans, so many have Anglican doctrines as their belief system and that coupled with the British as Israelites as their main platform.

So what does CI mean with the asks you ask? Well that will hinge upon who you talk with.

However, biblically speaking, Jesus coming back is a very open and unexplained term. But more accurately Jesus has never left. The assumption is that Jesus went away and left us to our lot.

THE BANNER OF THE NETHERLANDS

Just as Canadians had some controversies about a new flag, there was quite a flag fight in Holland before the last world war. There was a trend to change the old red-whiteblue flag into orange-white-blue without an orange ribbon. This ribbon was and is used only when the Dutch flag flies during festivities in connection with the Dutch royal family (i.e. the birthday of the queen/king)

This fight suddenly came to an end, when a greater fight started and the Germans took our country and occupied it for five years. During those years 1940-1945 the red-white-blue flag was forbidden by the Germans. Instead they flew the swastika and a pseudo-Dutch flag invented by some Dutch collaborators in black-red colours.

Try to imagine that you don't see your own flag flying in your own country during five years of oppression. What would that arouse in you? Imagine then that from all your buildings were hanging, well, for instance a hammer and sickle. Would that put you to sleep or awaken you?

Well, strangely enough the Germans were used without knowing it, to awaken a sort of unconscious Israel-identity within the Dutch people. Many Dutch flags were confiscated, but most people had hidden their flag somewhere (hide your wheat from the Midianites!). So, when the day of the liberation came, suddenly from everywhere the redwhite-blue flags appeared, and they jubilated, so to speak, from official buildings and private homes. There were the ancient colours of Israel again!

The free Anglo-Saxon world had given them back to an oppressed country, and all together they had conquered the swastika flag and the black-red one.

Now, these years had awakened many Dutch, and the controversy about the flag colours had stopped. Although still blind as to their true meaning, they chose for their Israel-identity unconsciously, and in the year 1949 the Dutch government officially decided the national colours to be a combination of vermillion red, white, and cobalt blue. Here again Holland gave a proof of being connected with the true Kingdom.

Why the banner of the Netherlands red-white-andblue? To us, as Israelites, this is very clear. They are the colours of every Israel country [although enemies have worked and are working to eliminate these colours from flags]. The red-white-blue of the curtains of the tabernacle (Ex. 25:4) and for us this is a symbol of Holland being connected with the lost tribes of Israel of old. But all this is unwritten, sacred history, so far.

What does recorded history say? The encyclopedia and some books, and books on the Dutch flag cannot trace it further back than the year 1572, when it was used by William the Silent (of Orange), who as you may know was our great hero. He fought for religious freedom against the supremacy of Papal Rome and the Spanish conquerors and Inquisition. The Dutch Protestants fought during 80 years for their freedom, double the length of Israel's sojourn in the Wilderness. As a result of this fight, won by the "Hollanders," the Netherlands became noted for their religious freedom and tolerance (this was the birthplace of America's 'First Amendment'). This also was the reason why hundreds of years later these Israelites who would become the Pilgrim Fathers, fled to Holland (Leiden) first. From there they sailed to the New World aboard the Mayflower.

The flag of the Netherlands is a horizontal tricolour of red, white, and blue. Variants of the flag have been in use since 1572, and in 1937 the flag was officially formalized as the national flag of the Kingdom of the Netherlands. It is the oldest tricolour flag still in national use.

The National Anthem of the Netherlands, the WIL-HELMUS, is also the most Christian-Israel-oriented national anthem in the world.
