CHRIST'S CHOSEN CAN BE SURE OF ETERNAL SALVATION by Ps. Ken Lent

For Saxon Christian Israel

Jesus said, "Ye have not chosen me, but I have chosen you -- " (John 15:16)

"I am not sent but unto the lost sheep of the House of Israel". (Matthew 15:24)

Choosing Jesus?

You have heard it said that you "have to choose Jesus Christ and let Him into your heart as your personal saviour" in order to have eternal life. However, those words never appear in the Scriptures but rather it is Jesus who tells us that He has chosen His own family and has given them eternal life. If you are one of Christ's chosen there will be a time in your life when you will discover what Christ has done for you and that He has secured your eternal salvation upon His bloody cross. In fact, it is only the chosen in Christ who will be led to profess their salvation relying on the Saviour Jesus, and to truly believe in their hearts that God has raised Him from the dead. Christ also says that He has provided the proof which shows that one's belief is Scripturally true and God given.

A misunderstanding about repentance unto eternal salvation

Repentance means to have deep sorrow that causes a change. The Scriptures teach that "repentance" holds two distinct positions.

(#1), One is the position that it has with eternal salva-

(#2). The other is with regard to the laws of God for the family and nation.

These two applications are as different as using fire

for light in a lamp or for using fire to cook a meal. Confusion about repentance has led many spiritual truth seekers astray because the denominations have mixed these two meanings and have used them interchangeably without Scriptural authority to do so. But God's Word explains the simple truth of the matter.

Repent #1

There is an unsound doctrine in most churches which teaches that a person needs to stop sinning in order to receive the salvation given to us by Christ. This doctrine is centered upon the age old problem of sinners, namely – self righteousness. Born out of the ever present humanist influence (but portrayed with a Christian wrapper) this doctrine views repentance unto eternal life as a change that a person must make in their lifestyle.

How many times has a lost sinner been told "Repent to change your life, choose Jesus, and you will be saved?" Some even add "change your life, get water baptized by Jesus' name, and you will be saved". Dear friends, the Scriptures define such a reasoning as an ungodly doctrine of the most seducing sort. Churches that teach either of these positions are teaching false doctrine as their incorrect motives are exposed by the light of God's word that reveals them as imposters leading the sheep astray. As backwards

as it may sound to the thought process of man, it is not a repentance of a changed lifestyle from sin that reveals the eternal salvation of Christ to a person. (A changed lifestyle shortly follows afterward) Repentance unto salvation does not mean a change of life, but rather a change of mind and heart. An attempt to stop sinning is not repentance unto eternal salvation. Also, an attempt to use water baptism for a remission of sins is not repentance unto eternal salvation. These things are doctrines of self righteous acts and are found in the false religious decrees of the Roman Catholic Church, the Church of Christ sect, and the Lutheran denomination, among some others. These sects have taken parts of God's word and turned them into things they are not. But God's certainty stands firm -- "By grace are ye saved through faith; and that not of yourselves: it is the gift of God, not of works, lest any man should boast." (Ephesians 2:8.9)

There is but one thing that God says quickens the truth of salvation in a chosen person, and that is a repentant mind/heart change which acknowledges that we are sinners guilty of eternal death and that we must rely only upon Jesus Christ, the Messiah of Saxon Israel, for forgiveness of those sins. It is the righteousness of Christ that is imputed to us that has saved us.

We simply trust God for this.

We are only asked by God to change from our carnal thinking that we can save ourselves (by either humanitarian works or religious rites), to admitting that only by pure faith in the name of Jesus Christ, all that He did in that name by faith in His shed blood for remission of sins – are we saved. Some may say "Faith without works is dead" (James 2:20) "so I want to work out my remission of sins by water baptism plus faith in the blood of Christ". By misquoting the intent of Acts 2:38 some ministers tell their congregations that this must

be done. However using baptism out of line with Scripture is not an act of faith, but an act of unfaithfulness in a twisted downgrading of what Christ did on the cross for us. Our salvation is not the cross of Jesus to the glory of His name -- plus -- anything. It is the cross alone by faith in His blood that is our salvation. Water baptism is a New Testament commandment that we are surely to obey as a symbolic profession of the faith which we have been freely given, but it is not for washing away sins, and it is not some dual component added in some attempt of remission of sins.

God's Word demands us to know that trying to stop sinning or attempting a religious rite does not define our spiritual repentance unto eternity. It is the repentance (sorrow and change) of our understanding (from placing faith in man to placing faith in Christ) that makes us fully aware of our eternal salvation which we cannot bring about as mortals. God leads us to have a change of mind with respect to this blunt truth. That is what is meant in Mark 1:15 "repent ye and believe the Gospel". Although a conviction to not let sin reign in our lives is a fruit of our faith and certainly has a needed and proper place, trying to stop sinning is not a repentance belief of the Gospel unto eternal salvation. It simply can't be done, yet how many churches tell us that it

is not by faith only in the blood of Christ Jesus, but it is the blood plus something else that will somehow supposedly make better contact with God for our eternal life's salvation? The peace of Christ is this – Jesus came to save sinners, and He did it on the cross. It is belief in this truth that saves. "(Jesus) whom God hath set forth to be a propitiation through faith in His blood, to declare His righteousness for the remission of sins that are past, through the forbearance of God" (Romans 3:25)

"To Him (Jesus) give all the prophets witness, that through His name whosoever believeth in Him shall receive remission of sins" (Acts 10:43)

"But these are written, that ye might believe that Jesus is the Christ, the Son of God; and that believing ye might have life through His name" - (John 20:31) "And this is the will of Him (the Father) that sent me, that every one which seeth (knows) the Son, and believeth on Him, may have everlasting life: and I will raise him up at the last day." Repent #2

Then just how does a changed lifestyle fit in?

God's Word teaches that the proof that a person has repented in his mind and heart to know the free gift of eternal salvation for Christ's chosen (by faith in the

bloody death, burial, and resurrection of Jesus and nothing else in addition), is that this person is so touched in his inner most being and he is overwhelmed by the power of Christ in him that he now discovers that he is following God's laws because he loves to, not because he has to.

A person could say they have faith, when they actually do not, which would be Scripturally revealed by the fact that they repudiate God's laws while claiming to be a Christian. (Mat.7:21-23; Rom.3:31; Ecc. 12:13)

A person could say that they obey God's laws when they don't, but follow in all manner of "damnable heresies" (II Peter 2:1) in a charade of God's laws. In this case God's laws are often adulterated with outlandish teachings along side of them. (Amos 3:3) These go beyond mere differences of opinion within Scripture searching.

But here is what Christ said would happen as a proof of true salvation:

A very important Scripture verse concerning this truth has sadly been mistranslated from the Greek New Testament text into the English version Bibles as we read it today. That verse is in the Gospel of John 14:15 where Jesus says, "If ye love me, keep my commandments". However the literal Greek text of this verse reads, "If ye love me you will be keeping my commandments." This is a state-



ment of fact by Jesus. It is not a plea from Jesus to beg a person into obeying God. God's chosen in Christ love Him, and love to keep His laws! That is the proof that you really do understand what happened on the cross of Christ and that you really do believe that He was raised from the dead. The apostle John tells us the same in his Epistle of I John 2:4,5:

"He that sayeth, I know Him, and keepeth not His commandments, is a liar, and the truth is not in him. But whosoever keepeth His word, in Him is the love of God perfected: hereby know we that we are in Him."

This does not mean, concerning obedience, that we are puppets on a string and we don't need to make choices. We do. But God is telling us of His omnipotence in that He knows before hand even who the ones are that will be making those correct choices in regard to their actions.

Keeping God's commandments does not secure eternal salvation since eternal salvation is the gift of God through Jesus Christ for His chosen. The apostle Paul tells us that sin caused our entrance into a dying short life and that God rescued us from this by His gift of eternal life. Then Paul explains that God's laws are not done away with on the grounds that He has freely given His chosen ones eternal life by faith in Christ.

"For the wages of sin is death, but the gift of God is eternal life through Jesus Christ, our Master." (Romans 6:23)

"Do we then make void the law through faith? God forbid: yea, we establish the law." (Romans 3:29)

"For this is the love of God, that we keep His commandments: and His commandments are not grievous." (I John 5:3)

God's Word is clear. Eternal life is a free gift, and those who have it wholly trust that Jesus is Master of their lives and that God has raised Him from the dead. The proof that this belief is actually a pure belief within a person's heart, is by what

Jesus said "You will be keeping my commandments." That is the real power of Christ, and the promise of His word for those He has chosen. Love negates habitual disobedience against God. Jesus loves His chosen. If Jesus' love is within a person the proof is evident -- he loves God's laws.

What happens when a chosen believer in God's family sins by violating God's laws? "Sin is transgression of the law" (I John 3:4)

Water baptism proponents who teach that our sins are cleansed from us only when we obey a church doctrine of making a sacrament out of water baptism for a work of remission of sins, will tell you that you can never be sure of eternal salvation. They consider the work of baptism to be an act which saves a person and that any subsequent fall into a sin puts the person at risk of losing eternal salvation. With this nonscriptural viewpoint the only way that a person can really be sure to be eternally saved is for the minister to water baptize a person and hold them under the water to drown them so that they will not live one day beyond their supposed perfection of their attempt to use water baptism for remission of sins. Contrary to this god-forsaken doctrine that destroys the overcoming faith of God's children in their daily walk, we have the promises of God that Christ has secured our eternal salvation.

So what happens when sin trips up a saved believer, which happens to our remorse?

Father is not a merciless dictator. He knows all of our weaknesses. When a son or daughter of God stumbles and falls out of a mortal weakness and confesses his/her sins to God, God sees the conquering blood of Christ and God forgives the sin, picks us up, and encourages us to start anew.

"If we confess our sins, He is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness." (I John 1:9)

Make no mistake about the power God in that it is His will to hear our prayers of confession of sin, cleanse us from that unrighteousness, and for us to have confidence that we have a Father who hears our petitions.

"And this is the confidence that we have in Him, that, if we ask anything according to His will, He heareth us, And if we know that He heareth us, whatsoever we ask, we know that we have the petitions that we desired of Him." (I John 5:13)

The repentance of mind and heart in knowing that belief in Christ saves us resonates with our gift of eternal life. But repentance of our lifestyle by confession of sins when we fall in "our fight" has to do with God's blessings and curses upon us in the "here and now". This understanding is not to be mixed up in a confusion of man made church doctrines or it will result in a frustrated spiritual life

that is not meant to be among the children of God. Christ loses none of His that hold eternal life by faith. When the child of God realizes this he becomes a conqueror now. Does the world and sin defeat us? "Nay, in all these things we are more than conquerors through Him that loved us." (Romans 8:37)

Until resurrection day when we are raised from the grave, we are going to be in a war against the carnal flesh that tempts us in our struggles of this age. But sin is no longer the dominant way of life for the saved in Christ, and salvation is not lost to an infrequent backsliding. No, it is not "ok" to backslide. But God

never rejects a backslider. Backsliding is handled by God chastening His child in order to bring him/her around into obedience again by His love for us. Our Father does give "love spankings". To whatever degree it takes to bring a faltering chosen son or daughter of God back into His blessings in the "here and now" the punishment will be administered until the lesson gets through. But once you are chosen in Christ, He does not lose you, being the Good Shepherd that He is. To think that Christ loses His chosen to a backsliding incident is contrary to the Scriptures. Such a notion would set aside the intercession of Christ for fallen believers, and plunge them into total despair. This is not the love of God. In fact, if you stray from the fold get ready to be effectively prodded by God's love to bring you home.

"My sheep hear my voice, and I know them, and they follow me: And I give unto them eternal life; and they shall never perish, neither shall any man pluck them out of my hand." (John 10:27, 28)

"For whom God loveth He chasteneth, and scourgeth every son whom He receiveth" (Hebrews 12:6) "If ye endure chastening, God dealeth with you as sons; for what son is he whom the father chasteneth not?" (Hebrews 12:7)

This is all a family matter. God is expanding His family and bringing His family into the actuality of eternal life. Those whom Christ has chosen are becoming overcomers of the death doomed world system that plagues the Earth

CAN AMERICA AND OTHER ISRAELITE NATIONS BE TRANSFORMED?

I have been invited to speak at a conference coming up in April in Branson, Missouri along with other pastors. I wanted to give you a preview of what I will be talking about. I am going to be asking and discussing "The Two Most Important Questions" that should be asked by every individual. They are life-changing questions. I hope to add some insight on these questions from the Bible. I have great expectation that the God of our fathers will come in power upon His Covenant People at this conference. But first, let me offer a preliminary, background question to my topic for this conference: Can America and other Israelite nations be transformed?

Where We Are At

From 1996 to the present, I have studied and collected public documentation on what has gone on and continues to manifest as an all-encompassing, global control. Almost every area of life is increasingly affected: electronic, usury debt/credit economic system, environment, education, legal, religion, and global government are among the main categories with numerous sub-categories under each one. And let's not forget the multicultural, diversity and inclusion programs that have infiltrated our lands. It is a present on-going process and it is real.

My conclusion is that this global steamroller agenda has been, is, and will continue to be implemented unto a planned, orchestrated destruction of God's true Covenant People. No political or ecclesiastical powers are able to stop it and most promote this agenda. And the vast majority are so deceived now, they can't see the problem nor can they comprehend the consequences.

As it stands now, our historic White nations are finished and there is no remedy except

ished and there is no remedy except physical conflict. We will not survive, unless....

Is There An Answer?

By that I mean, integrated and interdependent people comprising a church body that demonstrates to the surrounding people in a local area what a true, biblical community can be. The local community, in effect, becomes a self-sustaining and self-perpetuating living assembly as an example of what the Kingdom of God

SCHOOL SHOOTING PLOT EXPOSED: YOU WON'T BELIEVE WHO SET IT UP By Onan Coca February 24,

For the last week or so, the entire nation has been talking about gun control — or at least the media has been talking about it.

The sudden tsunami of gun control stories, articles, op-eds, and segments is the result of the terrible mass shooting that took place at Marjory Stoneman Douglas High School in beautiful Parkland, Florida. Sadly, the focus on gun control has caused the media (and the people who get their news from the media) to miss the far-

First, let me be clear; I'm not talking about the scandal of four police officers being on scene when the shooting begins, but who chose to do **NOTHING** [editor's note: It has now come out that they were ordered to stand down.] while waiting outside for backup. This is a scandal in and of itself, no doubt, and it should be investigated. The police force that allowed this to happen should be shamed for it. The shooting could, and should, have been far less bloody if only these officers had done what their community expects of them.

larger scandal revolving around Douglas High School.

Second, this isn't about the scandal unfolding at the FBI, who knew of Nikolas Cruz and his grotesque desires for mayhem and violence. This isn't even (entirely) about the failure of policing that took place in the months and years before the shooting – a time period that saw local police visit Nikolas Cruz 39 different times for various episodes of violence and criminality.

And finally, it isn't about how a troubled young man, so clearly mentally and emotionally distressed, ran afoul of the law so often, but was still somehow able to pass a background check to purchase his firearm.

No, this piece is about how, at every level, the government failed us by not enforcing our laws or even abiding by simple, logical standards of behavior.

Before I launch into this, let me give credit to the folks at **The Last Refuge** (https://twitter.com/TheLastRefuge2) The Conservative **Treehouse** (theconservativetreehouse.com) and did much of the legwork on this story long before the shooting at Douglas High School. In fact, the Last Refuge was investigating this story years ago, in the wake of the Trayvon Martin shooting. I was able to independently confirm much of what the Last Refuge reported (see his Twitter thread on this story here) when I spoke, on condition of anonymity, with several sources, one of whom works in the central office of the Broward School District.

The scandal that the media is ignoring, but is probably the most important part of this story, involves the Broward County School District and local police agencies colluding to lay the foundation of the Douglas High School tragedy.

What do I mean?

The story all began about 6 years ago in Miami-Dade County (the county just South of Broward), where the school district was struggling to succeed. All of the data painted a picture of a failing school district.

The district noticed that large portions of their school populations were being arrested at a higher proportion than

the rest of their community, and they realized that if they could cut down on criminality of their students, they could quickly improve the data coming out of their schools

With this in mind, the entered district into relationship with their local police force and concluded a deal that would ensure the police would stop arresting so many of their students. This document is hard to read. Here

commended by the Florida Department of Juvenile Justice (DJJ) for dramatically decreasing school-related delinquency in Miami-Dade County Public schools.

M-DSPD has the distinction of decreasing schoolrelated juvenile delinquency by an impressive 60 percent for the last six months of 2011, which was the largest decline in any school district in the state. The police force is being heralded for adopting effective alternatives to arrest such as civil citations. The M-DSPD has also seen a 35 percent decrease in the amount of referrals to the DJJ.

Three years ago we set out to create and maintain a police department focused on redefining our role and reaffirming our values through prevention intervention, enforcement and education. Our mantra is education not incarceration," said Chief of Schools Police Charles J. Hurley.

M-DSPD have taken a student-centered approach to law enforcement by engaging and helping students and their families. With the assistance of school leadership, involved parents and community stakeholders, the police department has been able to cut student arrests by a remarkable 35 percent.

"I'm extremely proud of our men and women on the police force. It is our intent to demonstrate compassion and understanding to our students and their families when it comes to law enforcement. We have a student-centered police department first and foremost." Said Superintendent of Schools Alberto M. Carvalino.

The police department achieved success by employing many strategies including diversion programs, mentoring, policy reform, home visits, truancy sweeps and public

support. Through these initiatives, graduation rates and student employability have increased.

Within a year or two, surrounding communities began to notice the change in Miami-Dade's fortunes (which included a new influx of money), and Broward County decided that it was time they entered into a similar deal with their local police force.

The Broward County School Board and District Superintendent entered into a political agreement with Broward County Law enforcement officials to stop arresting students for crimes.

The motive was simple. The school system administrators wanted to "improve their statistics" and gain state and federal grant money for improvements therein.

It's important to remember that this was not an arbitrary change; this was a well-planned fundamental shift in the entire dynamic of how teenagers would be treated when they engaged in criminal conduct.

I'm sure that you probably already see the problem with the police in South Florida entering into these deals with their local school districts.

In a very real way, the new policies made public school students above the law. These policies conflicted with laws that police officers had been long-trained to follow, but now it allowed students to act as they wished, without fear of the consequences. At first, the police were only "excusing" misdemeanors, but soon they were also "excusing" felonies, including violent crimes like assault, armed robberies, and worse.

You can obviously see how this would cause problems, but it's worse than you think. Once the system seemed to be "working," the district needed the police to continue lowering arrests year-over-year, which meant that the police were being forced to excuse ever more severe criminal acts.

From the *TheLastRefuge*: "Over time, even the most severe of unlawful conduct was being filtered by responding police.

We found out about it when six cops blew the whistle on severe criminal conduct they were being instructed to hide. The sheriff and police Chiefs were telling street cops and school cops to ignore ever-worsening criminal conduct.

The police were in a bind. They were encountering evidence of criminal conduct, and yet they had to hide the conduct. There were examples of burglary and robbery where the police had to hide the recovered evidence in order to let the kids get away without reports. The police would take the stolen merchandise and intentionally falsify police records to record stolen merchandise *as if* they just found it on the side of the road.

They put drugs and stolen merchandise in bags, and sent it to storage rooms in the police department. Never assigning the recovery to criminal conduct. Stolen merchandise was just sitting in storage rooms gathering dust.

They couldn't get the stuff back to the victim because that would mean the police would have to explain how they took custody of it. So they just hid it. To prove this was happening one of the officers told me where to look, and who the victim was..."

According to *TheLastRefuge*, an internal investigation was carried out, but the results were buried, because what it found was not politically or economically expedient for the county.

In the years following, youth crime in Miami-Dade and Broward steadily grew worse. An odd quota system developed, and once a certain number of High School students had been arrested in the county, leadership would make sure that other crimes committed would be excused.

To make matters worse (as if this wasn't bad enough), South Florida's gangs quickly caught on to the scheme and began using high school students to commit more of their crimes. They also began planning their biggest, most important activities later in the month, later in the quarter, and at times when schools were collecting their data for reporting. In this way, the gangs could take advantage of committing their crimes at the time when the police would be most likely to give their high school aged members a pass. Now we're getting closer to how all of this led to the

Douglas High School shooting.

With the intricate nature of the relationship between the police and the schools, it became vital that the School Resource Officers (SROs) placed at the schools understood how the symbiotic relationship between district and the police was supposed to work. They needed SROs who were adept at ensuring the criminal activities of their students would not be reported as crimes endanger the district's political and financial fortunes. This is likely why the demonized SRO Scot Petersen (who infamously stood outside the school while the massacre was in progress), likely refused to information on the shooter with

social services back in 2016. "Peterson is mentions as part of 2016 social services agency investigation into Nikolas Cruz, the 19 year old identified by police as the gunman. These problems with the SROs in South Florida are not something new. There have been *other investigations that uncovered their questionable behavior*, but again it wasn't convenient to end the practice. In the wake of the Douglas High School shooting, these problems should be too big to hide. Sadly, instead of covering the ongoing corruption of



the law that has been happening in Miami-Dade and Broward counties since 2012, the media has chosen to focus their fire on gun control.

Instead of worrying about guns, the media should be asking how could *local police pay 39 different visits* (Broward Police claim it was "only" 23 visits) to one student without that student ever spending significant time in prison or a psychiatric ward. They should be asking why the local police wouldn't share information about this high school kid with social services or other law enforcement

The truth is that our laws and law enforcement procedures were enough to stop the Douglas High School shooting before it ever happened, but because of the corruption sowed by the Broward County School District and local police leaders, those laws and procedures were

If the procedures (and laws) had been followed, Cruz would have never been allowed to purchase a gun. He would have likely already been incarcerated, and he never would have had the opportunity to kill 17 people. *This case* isn't about guns. And the answer isn't more gun control.

This case is about school districts lying to their families in an effort to get more money and more political influence. It's about local police forces being willing to ignore crime and refusing to abide by the laws that they promised they would uphold. It's about government failures at every level and how that corruption and failure led to the death of 17 innocent people. Don't let the media sell you some sob story about how we need more gun control in this country.

This is all about corrupt politicians and money.

STEALING AT SELF-CHECKOUT by Joel Hilliker

When you go grocery shopping, do you have to fight urges to steal? What holds you back from just walking out of the store without paying for your foodstuffs? I don't recall feeling those urges, but at least one of my fellow shoppers says this makes me a "moron."

Apparently many shoppers are paying for their groceries only because someone is *making* them do so. How do we know? Because now that self-checkout lanes are becoming common, more people are shoplifting.

A recent University of Leicester study audited 1 million self-checkout transactions over a full year and found out of \$21 million in sales, people shoplifted almost \$850,000 worth of goods. In one survey, nearly 1 in 5 people admitted that they use the self-checkout lane to steal stuff.

These facts come from "The Banana Trick and Other Acts of Self-Checkout Thievery" in the Atlantic, an eyeopening look at the shenanigans that are now common

place, such as ringing up pricey cuts of meat with codes for cheap ones, and stuffing banana bunches with unpaid-for extras. Some of these scams require real ingenuity and effort; others, apparently, aren't terribly difficult to

Some people suggest that stores actually encourage theft by making it so easy. The Atlantic wrote, "In their zeal to cut labor costs, the [Leicester] study said, supermarkets could be seen as having created 'a crime-generating environment' that promotes profit 'above social responsibility'" (March 2018). So apparently these thefts aren't the fault of the thieves, but of the store owners!

Some people have come to view theft at self-checkout as some kind of right. The Atlantic quoted one shopper commenting online: "Anyone who pays for more than half of their stuff in self-checkout is a total moron. There is NO MORAL ISSUE with stealing from a store that forces you to use self-checkout, period. THEY ARE CHARGING YOU TO WORK AT THEIR STORE" (emphasis his). This individual reasons that he is entitled to steal at least half of the items in his cart because of the 2-1/2 minutes he spends at self-checkout.

THE LOST(?) TEN(?) TRIBES

[note by TKC editor: I met Don Robson in Toronto in 2003, at a BIWF Conference at which I was honoured to speak. Don provided their music and I later learned he was also a composer of note. He was a former IBM executive and the questions he posed during the conference depicted a highly knowledgeable Bible scholar. To my surprise, when I suggested he write for TKC magazine, he agreed to give it a try. What a great coup that was. Don quickly became a most popular writer because of the many enquiries from readers we began referring to him as our Senior Correspondent. continued writing until he passed on a few years ago but in pure Don fashion, he left us sixteen articles to publish as needed after he was gone. A most remarkable fellow]

Personally, I feel that the extensive use of this phrase has contributed in no small way to the confusion which exists concerning the Jewish people living in Palestine and other countries throughout the world. I think it is fair to say that the general belief is that Judah, including Benjamin, was taken to Babylon from where some returned to Jerusalem under Ezra. Hence they were not lost!

It seems to me that the word "lost" may have another connotation; such as, lost to idolatry and sin and consequently, death. Moses challenged the people of Israel in his farewell address, where he said, "This day have I put before you life and death; blessing and cursing, therefore, choose life, that both you and your children may live!" (Deu 30:17) Of course, we know the people were seduced by the Canaanites into worshipping their gods and all the curses outlined by Moses came into effect. But then came the good news of the Gospel. Jesus, the promised redeemer, had come bringing salvation through His sacrificial death. Good news indeed, and Jesus insisted with His disciples that the message be carried to His people, just purchased by His atoning sacrifice. Further, we know the disciples were faithful to Jesus' command and carried the Gospel to the children of Israel throughout western Asia and Europe. By the way, I should emphasize that Jesus did not say, "Go to ten tribes," but, "Go to the Lost sheep of the House of Israel," meaning ALL twelve tribes.

Now, to understand the situation with Judah, we need to review some basics. First, the Bible records that Sennacherib conquered all the tribes of the Northern kingdom in stages. First, the two and a half tribes on the eastern side of Jordan: namely, Reuben, Gad and the half tribe of Manasseh. Then, he took the remaining tribes in the west side of Jordan concluding with the capture of Samaria. Then the Bible records that he took ALL the fenced cities of Judah, except Jerusalem, deporting about 200,000 people of Judah. So, Sennacherib sent all these people (all TWELVE tribes) to Assyria and the cities of the Medes. The poorer sort of people he left in Palestine and added to them similar people from Assyria. As you know, Sennacherib ended ingloriously when he was besieging Jerusalem and the Angel of the Lord was sent to decimate his army. On returning home, he was slain by his two sons. So, all that remained of the House of Judah was the city of Jerusalem. We also know that under Cyrus' decree, Ezra returned with about 50,000 of the people that Nebuchadnezzar had deported to

Babylon from Jerusalem. (An interesting aside concerns when Simeon was conquered, as part of Judah. Although numbered with the ten tribes, it actually was south of Judah and therefore presumably captured after the fenced cities of

of Jerusalem for bloodline, lived mainly Jerusalem.

Judah and deported with them!)

In summary, we must say that the Assyrians deported ALL twelve tribes of Israel, leaving only the Babylonians! But does that account for all the Judahites? I think not. Let's review. Judah had five sons, three by a Canaanitish woman and twins, Phares and Zarah, by Tamar. Two of the first three were taken by the Lord for their evil practices. Shelah, with his contaminated

You know the story of how the midwife tied a scarlet thread on Zarah's hand when it appeared but when withdrawn, Phares was born. So, once again rivalry was established. It has been shown by others that some of Zarah's progeny left Egypt before Moses led the Exodus from Egypt. One son, Dara, migrated to the area of the Dardanelles and established the Trojan dynasty. Another son, Calcol, migrated to Greece and from there to Ireland. This established Judah in the Isles to await the reception of Tea Tephi in marriage thereby transplanting the Davidic dynasty to the British Isles and reconciling the Houses of Phares and Zarah. Furthermore, after the destruction of Troy, Brutus led a group of Trojans to Britain where he founded New Troy, later named London. And I am quite certain that Zarah Judahites were part of the colonizing that occurred on the North and South shores of the Mediterranean Sea.

So let's sum up. In this thesis, "lost," does not mean geographically, but spiritually. The Assyrian deportations included ALL twelve tribes. Parts of Judah were located in other areas besides Palestine and never subjected to deportation. Finally, consider the opening of James' epistle, "James a servant of God and of the Lord Jesus Christ, to the twelve tribes which are scattered abroad, greeting." Some of the Judahites returning with Ezra were

pure Israelitish stock because the book of Acts of the Apostles records that some were converted to Christianity. How are Christians to live in the Babylon of modern society and not be corrupted by it—to be in the world and

not of it? The example of Daniel and his friends in ancient Babylon shows us the way.

Should you, as a Christian, be relevant to the culture around you? Is the gospel message of the Bible relevant to society? Should you be relevant? Are you relevant? Culture changes, and it changes quite fast. What we are able to do in our modern, connected, Internet age would astound even recent generations—not to mention how foreign it would be to characters of the Bible. But, while the *methods* of communication have changed, the message to be communicated never changes.

The message of God, His Word, is always relevant—if only

people would truly understand what it is. In our world today evil has blinded humanity to the relevance of the gospel message.

One example of the importance of cultural relevance when it comes to the Bible is the YouVerion Bible app for smartphones and tablets. This app was created by Life. Besides being a prophet, with his book containing the most comprehensive and sweeping prophecies in the Old Testament, Daniel also worked as a government official and scholar. As one of the most learned men of Old Testament times, he was thoroughly trained for his important role in government, history, wisdom and

We must wonder: What must it have been like for him

to live in Babylon back then? What kind of cultural challenges did the people of God face then? Perhaps we should consider: What's it like for God's people today to live in this nation or, really, any country in a sinful fallen

Babylon or Babel, site of the famous tower and starting place of the first empire after the Flood (Genesis 10:8-10, 11:1-9), is an archetype of civilization in opposition to God. In many ways our country, along with every country, is a continuation of the ancient Babylonian way! What good did Daniel bring to his society? What good can we bring to ours? How can we ensure the biblical message is relevant to those we interact with on a daily basis?

After all, while we must live in the Babylon of this world, we are not to be of it. The requirement to come out of Babylon means to come out of its ways (see John 17:14-

18, Revelation 18:4-5).

Living In Babylon Without Assimilating

The opening verses of Daniel give the historical setting, which includes the first siege of Jerusalem by the Babylonians in 605 BC. King Nebuchadnezzar of Babylon demanded tribute from this new part of his empire, along with certain Judean men to be trained to serve in his court.

Among these were Daniel and his three friends Hananiah, Mishael and Azariah, who were all renamed with Babylonian names—Daniel as Belteshazzar and his three friends as Shadrach, Meshach and Abed Nego (Daniel 1:1-7).

This takeover of Judah and initial deportations of Judeans to

Babylon was part of the fulfillment of many warnings from the biblical prophets about Israel and Judah's coming disaster because of their sins against God. The nation had repeatedly forsaken the law and ignored God's covenant—including the keeping of the Sabbath [rest] day—and gone into idolatry (Ezekiel 20:12-13, 16-24).

The people of Israel (to the north of Judah) had been overrun and deported by the Assyrians more than a century earlier (see previous article above for a better explanation), and now the southern kingdom of Judah (actually only what was left after the Assyrians had been) was to be captured by the Babylonians. Sin resulted in the people of Judah being likewise carried off captive—now and in greater numbers in two more invasions over the next 18 years—to Babylon, itself a center of idolatry and one of the most wicked cities in the ancient world

How did Daniel and his friends live in that society? Consider too: How do we live in Babylon today? Just as the Babylonians? Or maintaining godly distinctiveness?

Imagine if you were dragged out of your home to serve a foreign dictator. Maybe you're given a new name to show his power over you, as it was Daniel and his friends. Maybe you're put in compromising situations that challenge your faith. What example would you set? What would identify you? Would you partake of the "king's delicacies," as we find in the next verse in Daniel 1?

Notice: "But Daniel purposed in his heart that he would not defile himself with the portion of the king's delicacies, nor with the wine which he drank; therefore he requested of the chief of the eunuchs that he might not defile himself" (verse 8, emphasis added throughout. With God's help, Daniel and his three friends made it through



this situation and worse difficulties to follow without giving in.

Daniel later foretold a more severe testing that would come to the Judah people more than 400 years later under Greek Syrian rule (see Daniel 11:28-32). Some historical details of what happened can be found in apocryphal books, one of which states: "But many in Israel stood firm and were resolved in their hearts not to eat unclean food. They chose to die rather than to be defiled by food or to profane the holy covenant; and they did die" (1 Maccabees 1:62-63.

Not compromising on God's Law in Babylon or successor kingdoms was serious business! You could be put to death (now many of these Babylonian evils are entered into voluntarily and promoted by the churches - abortion, homosexuality, interracial marriage, eating unclean food, etc). Daniel's strong devotion to biblical law came from a deep devotion to the God who gave it. Daniel's identity came from his God, not from Babylon.

Does your identity come from your relationship with God, or from the world in which you live?

Contribute to Society; be a good citizen

There are some elemental points we can glean from the life of Daniel and his companions in Babylon. Note, for instance: "As for these four young men, God gave them knowledge and skill in all literature and wisdom; and Daniel had understanding in all visions and dreams." (Daniel 1:17).

Daniel and his three friends had an intelligent understanding of the language and literature of the Chaldeans (Daniel 1:4) and were able to judge wisely between what was true and what was false. And they did all this while living as part of the Babylonian society!

This shows that education outside of the Bible can be good—provided it does not *replace* biblical truth. Daniel had skill in Babylonian culture and literature. We see that God does not expect us to close ourselves off from the world and live in a commune or monastery (compare 1 Corinthians 5:9-12). Again, we are to live *in* the world, while not being *of* the world. We live *in* Babylon, while not conforming to it.

And here's more to this point. Jeremiah 29 instructs the Judeans in Babylonian exile to live and work for the good of the pagan society in which they were immersed—yet without compromising on God's way. The Babylonian bureaucracy was hostile to the God of Daniel and his countrymen. But if they worked hard and set a godly example, they could have positive interaction and communication with the highest leaders in the empire.

The prophet Jeremiah lived at the same time as Daniel, although Jeremiah was around 20 years older. Here is what Jeremiah wrote from Jerusalem to Daniel and the other captives in Babylon:

"Now these are the words of the letter that Jeremiah the prophet sent from Jerusalem to the remainder of the elders who were carried away captive—to the priests, the prophets, and all the people whom Nebuchadnezzar had carried away captive from Jerusalem to Babylon....

"Thus says the Lord of hosts, the God of Israel, to all who were carried away captive, whom I have caused to be carried away from Jerusalem to Babylon: Build houses and

dwell in them; plant gardens and eat their fruit. Take wives and beget sons and daughters; and take wives for your sons and give your daughters to husbands, so that they may bear sons and daughters—that you may be increased there, and not diminished." (This applies to our people today in this modern Babylon as well!!)

"And seek the peace of the city where I have caused you to be carried away captive, and pray to the Lord for it; for in its peace you will have peace.... do not let your prophets and your diviners who are in your midst deceive you" (Jeremiah 29:4-8).

How do we live in Babylon? Jeremiah says to be a good citizen! Have families. Grow fruit trees and vegetables. Build homes. Don't break the law. Contribute to its peace. Don't follow false prophets who lead you away from God's instructions. So, do we live out godly principles that are a blessing to the city in which we work, in which we go to school? (or homeschool) Do you live like Daniel and his friends?

The Bible gives us solid, moral examples and instruction of how to live in Babylon—showing what it looks like to live faithfully in a religiously hostile world. Be a peaceful contributor to society. Grow gardens, raise families, work hard!

Irrelevant Christians?

Today some claim to follow God but, in reality, live a life of cultural accommodation. In trying to become relevant they become *irrelevant* in representing God. We must instead stand for and live

according to the truth even when doing so is hard.

We need to follow Daniel's courageous example. Instead of letting our friends, the media, the church and the latest crisis determine our outlook, we need to let Scripture and God's Spirit determine it.

Furthermore, Daniel genuinely desired the best interests of his captors. He endeared himself to them with humble service and a heartfelt concern for their well-being. What is the solution? We must live like Daniel. Live a disciplined life. Daniel was a faithful witness of God's way—whether he was ruling in the king's court, or later stuck in the king's prison. Godly ethics are the solution.

We cannot afford to try to deconstruct biblical truth. We must be unwavering and uncompromising when it comes to God's commandments, including Sabbath-keeping. We must be a light. Daniel's faith was not a secret. It is not a life of secrecy. We talk about what we love.

Social scientists have shown that the moment a church abandons its orthodoxy, the moment it goes liberal, the moment it becomes morally ambivalent, is when it signs its death warrant.

Major battles we face in Babylon today

Look at some of the major battles we face in Babylon



today. Self is at the center of everything. There is a disproportionate sense of self-awareness and "me:" I am of the utmost importance. I can do anything I put my mind to. I have the most social media followers "like" me!

One of the biggest goals of people today is to become famous. We live in a time when everything comes to us immediately, quickly. *I want it now!* We get impatient at the microwave, at the elevator, on the freeway. But what is the remedy? God should be at the center of your life, not yourself, not the wish for fame.

Another notion to resist is the idea that there is no absolute truth. Our culture today is amoral, leading to immorality. There is no right or wrong, so let's decide it for ourselves. It's that tree from the Garden of Eden again!

What is the solution? The ethics of God are not the ethics of Babylon. Don't be morally ambiguous. We need a godly, moral firmness.

Today's Babylon has an obsession with spectacle and noise. We've given ourselves to the great gods of entertainment and media, of fantasy, of Hollywood, of

spectacle. We escape the chaos and pressure of life through entertainment and imagineering. Babylonians live a life that favors stadium-filled concerts, images, moving pictures and visuals rather that things of substance. The world, is on a different trajectory than each of us should be.

It is better to have conflict with society around us than to have conflict with God and diminished faithfulness to Him. "In this world you will have tribulation," we are told (John 16:33). We cannot be neutral

about our faith, but that is what many people prefer to be. People want to be part of the system to become Babylonians.

Could the following be said of you, like the queen mother said to the new ruler in Babylon about Daniel? "There is a man in your kingdom in whom is the Spirit of the Holy God. And in the days of your [grand]father, light and understanding and wisdom, like the wisdom of the gods, were found in him; and King Nebuchadnezzar your [grand]father—the king—made him chief of the magicians, astrologers, Chaldeans, and soothsayers" (Daniel 5:11).

Daniel did not go with the Babylonian flow. No, he had the Spirit of the Holy God and it was recognized by others. Is that Spirit recognized in you and me?

Daniel's God was seen as very different from the gods of the Babylonians. Daniel's God was from outside of creation—from the spirit realm. But Babylonian gods came from everything around them, from inside creation—from the river, from the trees, from nature. They worshipped the creation rather than the Creator! The Spirit of the Holy God was very different from the gods of Babylon.

We will not all face a den of lions, as Daniel did late in life under Persian rule. For us it may be more subtle. Perhaps it will be a gradual decline of faith and obedience. But we are reminded that even the smallest of matters we must not be godless Babylonians.

Faithfulness and time with God

We must not partake of the "king's delicacies," as noted earlier, if they are in opposition to God's way. To put it in modern language, we cannot partake of the king's (our boss's) Christmas party, Halloween celebration or New Year's Eve revelry. We must live *in* Babylon but not become ungodly Babylonians. What is the solution? How

do we do it?

Do everything to the best of your ability. Be faithful even in the little things (Luke 16:10-11). Put your best into all you do. Stand by your word. As recorded in Luke 16, dishonesty, even in the smallest amount, leads to dishonesty in even greater portions. Dishonesty is directly opposed to godly truth.

Our character must line up with our God-given calling. Daniel's respect for God far outweighed his fear of what man could do to him. If you don't make time for God, don't be surprised if your faith fails—or if it seems that God is distant [If God seems far away from you - guess who moved?]

Whether our relationship with God will fall apart depends on the time we give to Him—just like in a marriage. Do we read the Bible (at least read the Bible at meal times, to your children)? THE RIFE MACHINE: HEALING WITH VIBRATIONS

Cancer continues to be a very deadly disease, and the question comes up time and again, "When are we going to find a cure?" Well there been many alternative have treatments for cancer over the years, Big Pharma, they quickly become labelled as quackety. One of these treatments, created about 80 years ago, is the Rife Machine. Before we talk about the machine itself, let's take a little peek at the man who invented it, Dr. Royal Rife. It goes without saying, the man was a genius.

Born in 1888, Rife developed technology over his lifetime which is still commonly used today, in the fields of optics, microscopy, biochemistry, ballistics and aviation. It is said that Rife practically developed bioelectric medicine himself. Because Rife was self-educated in so many different fields, he intuitively looked for answers in areas beyond the rigid, scientific structure of his day. Whenever new technology was needed to perform a new task, Rife simply invented and built it himself. Many have said that he had one of the most gifted and scientific minds in human history. Rife's creation of microscopes much more powerful than any other of his time, allowed him to view organisms and viruses that were virtually invisible before. Through his research he learned that every organism has its own frequency at which it vibrates. This led to the creation of his Rife Machine, which is known as a frequency generator. He found that generating frequencies on his machine would kill organisms at the same frequency. To understand how this works, think of a singer that is able to shatter a glass by singing the right note. The singer is simply singing at the same frequency that the glass is vibrating at.

And here's how the machine works. You begin by connecting the machine to your body at the site of the disease, or optionally under your feet. Once the Rife machine is turned on, the frequency waves travel through

your body, destroying all cells affected by that frequency. Normal body cells are said to remain unaffected by the frequency levels specific to the targeted micro-organisms. There may be side effects, such as nausea, usually after the first session only. This is just your body adjusting to the release of toxins. Treatments begin around 1/2 hour a day, 3 treatments a week, then increase in intensity.

The first clinical work was completed under the supervision of Milbank Johnson, MD, which was set up under a Special Medical Research Committee of the University of Southern California. Sixteen cases were treated at the clinic for many types of malignancy. After three months, 14 of these socalled hopeless cases were signed off as clinically cured by the staff of five medical doctors and Dr. Alvin G. Ford, MD, pathologist for the group.

In the summer of 1934 in California, a group of leading American doctors conducted the first successful cancer clinic. The results showed that: (1) cancer was caused by a micro-organism (2) the micro-organism could be painlessly destroyed in terminally ill cancer patients and (3) the effects of the disease could be reversed.

Popular Science magazine, along with many major newspapers, began to tell their readers about Royal Rife and his treatments. Physicians came from all over the

United States to verify his results. Over forty Los Angeles area physicians assembled to honor Rife for the work he was doing. Dr. Royal Rife was honored as "the man who had discovered a way to end all disease." His treatments of virus and bacterial infections and microscopes were praised by the Smithsonian Institute in an article published Institute's in the publication.

But just like Nurse Rene Caisse (she cured many with her Essiac herbal concoction), and Henry Hoxey with his similar treatment, Dr. Rife's life was about to be turned

upside down. Long and expensive lawsuits brought on by the American Medical Association financially ruined him. The last thing in the world the pharmaceutical industry wanted was a cancer cure that only cost the use of a little electricity. It might give people the idea that they didn't need drugs.

Rife was emotionally destroyed by his treatment in court and his entire program eventually dissolved. Many papers in Rife's laboratory in San Diego also disappeared, as did parts of his precious microscopes. Physicians using his treatment program were threatened by the AMA and the State of California with the loss of their licenses if they continued on the program. Top doctors and scientists who have worked alongside Dr. Rife for many years were now denying they had even met him.

In one of the blackest episodes in recorded history, this remarkable electronic therapy was sabotaged and buried by a ruthless group of men.

It has been written that after the loss of his lab and due to the mental and emotional results of the lawsuit, Rife became an alcoholic. Despite his immense contributions to medical science, he died friendless in 1971 at the age of 83.

Fortunately, the Rife machine has re-emerged in the alternative health field since the mid 80's. Doctors and engineers were able to reconstruct his frequency instruments and kept his genius alive. Rife technology became public knowledge again in 1986 with the

WHAT THE BIBLE SAYS ABOUT NORMAL

If you randomly asked ten people how today's normal would be described in respect to, let's say, family or sexuality, what would they say? What is normal today and who decides that? Why is it important? Because unless you have been sailing on the ocean for the past 50 years without contact from the outside world, you will have noticed how things have changed – radically! Traditional meanings of words and concepts have been altered.

What is increasingly considered "normal" today would have been completely foreign to the mind just 50 years ago – or even 30 years ago.

Marriage, Family and Sex

I recall from yester-year a song by the Beach Boys. The song is about how nice it would be to be married to a particular girl so they could live together ("Wouldn't It Be Nice" – 1966). That was over 50 years ago! That was the normal then, when a man and woman waited to live together in the same dwelling until they got married. Today that is not the normal. Most couples don't seem to have a problem with living together without a publicly expressed marriage covenant. 50 years ago (or less), it would have been considered immoral – forbidden. Now? Who cares? It's the new "normal." How did we get from there to here?

There are other categories of life that have also changed. One of the things I've noticed in the new "normal" today is the increasing acceptance of gender identity and sexuality such as transgender, homosexual or lesbian sexual relationships and now same sex "marriages." What was either unheard of or downright taboo and rejected 50 years ago is now accepted and glorified as "normal."

Race-Mixing, Etc.

How about racially mixed relationships? What was rejected and looked down upon, even 20 years ago, is now being heavily and constantly promoted as the accepted new "normal." All White countries are the target of more foreign immigration. Recently, the EU Commissioner for Migration said that Europeans must accept mass migration from the third world as the "new norm." Entertainment, commercials, catalogs – almost everything – is pushing Whites and Blacks or Whites and Asians as the "normal" family. I mean, not just holding hands, but openly "kissing"

for all to see. A shameless display.

How about racial integration propaganda? What commercial or TV show, for example, is not now racially-mixed? The emphasis of Blacks and Asians over Whites in many cases is obvious.

Is this all on purpose? Who has decided what "normal" is going to be like?

But it's just not these issues. It affects many other areas that have been around for a while. Just observe what is being glorified as normal:

Healthcare: medicine, medical doctors, chemical medications, surgery

Sports icons

Entertainment idols

Money barons

Religious celebrities

Higher education – Harvard, Yale, Stanford promoting communism, feminism and, of course, anything anti-White.

So, normal according to whom? Compared with the Bible and God Himself, all these are not normal, but are classified as abominations.

The Bible Is the Standard for Normal

In Luke 16:15, Jesus called out the Pharisees who sneered at His comment that one cannot serve both God and money or wealth at the same time. The Pharisees loved money and Jesus brought them up short:

"And He said to them, 'You are those who justify your-selves in the sight of men, but God knows your hearts; for that which is highly esteemed among men is detestable in the sight of God.' "- Luke 16:15

They justified loving money in pretense to loving God as their "normal." But their normal was an abomination to God.

The glorification and justification of any modern cultural "normalcy" that goes against God's order and design is rejected by God and His Law/Word. If God rejects it all, so should we. God will not compromise and neither should we. Who is going to hold up the cultural "normal" today to the light of the Bible if we don't? Expect a vicious reaction from those who need to justify themselves. But also realize that such a response by the "normal" crowd is the conviction of the Holy Spirit of Truth. They may reject you, but they are really rejecting God.

PSALM 78 verses 1 - 8

An exhortation both to learn and to preach the law of God Give ear, O my people, to my law; incline your ears to

the words of my mouth. I will open my mouth in a parable: I will utter dark sayings of old: Which we have heard and known, and our fathers have told us. We will not hide them from their children shewing to the generation to come the **praises of the Lord,** and his strength, and his wonderful works that he hath done. For he established a testimony in Jacob, and appointed a law in Israel, which he commanded our fathers, that they should make them known to their children: That the generation to come might know them, even the children which should be **born**: who should arise and declare them to their children: That they might set their hope in God, and not forget the works of God but keep his commandments: And might not be as their (great, great grand-) fathers, a stubborn and rebellious generation; a generation that set not their heart aright, and whose spirit was not steadfast with God.
