ONE RACE, ONE BLOOD, ONE LIE

Scripture Reading: Acts 17:22-28, ASV

"And Paul stood in the midst of the Areopagus, and said, Ye men of Athens, in all things, I perceive that ye are very religious. For as I passed along, and observed the objects of your worship, I found also an altar with this inscription. TO AN UNKNOWN GOD. What therefore ye worship in ignorance, this I set forth unto you. The God that made the world and all things therein, he, being Lord of heaven and earth, dwelleth not in temples made with hands; neither is he served by men's hands, as though he needed anything, seeing he himself giveth to all life, and breath, and all things; and he made of one every nation of men to dwell on all the face of the earth, having determined their appointed seasons, and the bounds of their habitation; that they should seek God, if haply they might feel after him and find him, though he is not far from each one of us: for in him we live, and move, and have our being: as certain even of your own poets have said, For we are also his offspring."

In the recent mid-term elections, the Republicans avoided a worst-case scenario: the "Blue Wave." Many good Americans breathed a sigh of relief. But, what about the "brown wave" (immigration). Paul at Mars Hill

Our Scripture reading is the account of Paul addressing the Greeks of the court (Areopagus) on Mars hill. His speech was somewhat of a shock to the prideful Greek culture. The Greeks took much pride in the accomplishments of their nation; indeed, they were the measure of all things; and every nation around them wanted to be like them. ("Man is the measure of all things." A statement by the ancient Greek philosopher Protagoras, 420 BC. It is usually interpreted to mean that the individual human being, rather than a god or an unchanging moral law, is the ultimate source of value.) The Greeks constructed five of the Seven Wonders of the World. The Greeks looked down on anyone else as inferior (barbarians) to them, even those of their own racial brethren. This is why Paul spoke of God, the creator of all things, who had "made of one, every nation of men to dwell on all the face of the earth..." (Acts 17:26,

The companion verse to this: "These are the families of the sons of Noah, after their generations, in their nations. And from these were the nations divided in the earth after the flood." - Genesis 10:32 (no mention of blood here

either). Paul is simply stating biblical history for the Greeks. In so doing, he "popped the balloon" of Greek arrogance. We could say that Paul wanted the Greeks to be more inclusive. But it was not the kind of inclusiveness of today's egalitarian. It was the inclusiveness within our own race.

Then, moving on to verse 28 of our passage, Paul adds this comment, "for in him we live, and move, and have our being: as certain even of your own poets have said. 'For we are also his offspring.'" This is a familial term — it is racial. Evidently, some of the Greek poets must have admitted that they were the "offspring" (children) of God the Creator; but they did not know His name or who He was. Well, Paul knew who this God was: He was the God of Israel. And Paul knew these Greeks were descended from the tribes of Israel many centuries ago. This is easily proven by how, Paul uses the term "Gentiles" in his letters. The people of the N.T. are the same as in the O.T.

Paul was being charged (as seen in Acts 17:18-20) with bringing in new doctrines; and perhaps false gods. But he assures them he was not. He saw what the city was like

everywhere he looked, there were gods. Acts 17:16, "Now while Paul waited for them at Athens, his spirit was stirred in him, when he saw the city wholly given to Surely, Paul must have idolatry. defended himself of these charges by saying something like, "you have plenty of gods already, and I do not need to add any more." Matthew Henry comments:

"Socrates, who had exposed the pagan idolatry, was indicted in this very court, and condemned, not only because he did not esteem those to be gods whom the city esteemed to be so, but because he introduced new demons; and this was the charge against Paul. Now he tacitly owns the former part of the charge, but guards against the latter, by declaring that he does not introduce any new gods, but reduce them to the knowledge of one God, the Ancient of days." -M. Henry

Paul did not condemn the Greeks for paying homage to "the unknown God" but says, this is the God I want to speak about.

'Then Paul stood in the midst of Mars' hill, and said. Ye men of Athens, I perceive that in all things ye are too superstitious. The use of the word "superstitious" in our language today sounds a little too negative and Paul was not expressing such, but was very respectful of the Greeks and their culture. Many translations use the word "religious" instead.

Concerning this passage, the JFB Commentary says:

"I perceive that in all things ye are too superstitious—rather (with most modern interpreters and the ancient Greek ones), 'in all respects extremely reverential' or 'much given to religious worship,' a conciliatory and commendatory introduction."

Paul was quite a diplomat in reaching his race, his fellow Israelites. This is biblical inclusiveness (within the race); and, the historic background for the passage in ques-

tion.

Blood

With a book that has in its title, "One Blood," using Acts 17:26 as its theme and proof text, one would expect there to be some analysis of that verse. But there is no study or biblical exegesis of this verse. There is no study of related scriptures. There is only presumption that it means what the authors say it means. In fact, One Blood. One

Race hardly uses any Scripture at all to support the authors' beliefs about race. Any book trying to build a doctrinal position based on one verse is very foolish. Any theologian studying the Bible knows very well that in order to conclude on a certain doctrine, one must examine all of the Scriptures of that particular subject in question.

Proof that "One Race. One Blood" is one big lie, is the fact that the word "blood" was originally absent from the text of the best authorities, including the 26th edition of the Nestle-Aland Greek New Testament and the 3rd edition of the United Bible Societies' Greek New Testament. Likewise, some translations do not use the word "blood." It is well-known that there have been errors made in the Masoretic text (from which the KJV comes)

of the Bible. This also brings up the possibility that the Masoretes (jews) also deliberately inserted words to sway the meaning of the text. After all, Jesus Christ said they were "liars" and would do the work of their father the devil. Proper understanding reveals that the word "blood" is awk-

ward for these reasons:

When we use the term "blood" today, we often use it to denote race, heritage, lineage or relationship. We might say someone is of royal blood or is mixed blood, etc. But the Bible does not use the word in this biological way. "Blood" is used to refer to the life-giving principle common to all, even animals. Following the same manner of the interpretation (presumption) of egalitarians would mean that we are also related to animals! The usage of the word blood to indicate a biological relationship is archaic, because up until recent times we had no knowledge of DNA or blood types: A, B, AB, O. It is a little known medical fact that the blood between the races is not the same. Yet, A.I.G. uses the word blood to indicate a biological relationship, claiming it is "scientific." These four blood types alone prove that not all blood is the same, or "one."

The only other way the Bible uses blood is in reference to sacrifice or atonement. It was not used to indicate the biological relationship of people. Therefore, it is a monstrous error, or blatant lie, to say that "one blood" in Acts

17:26 means "all people are related."

The word "blood" was never used in the Bible to convey the idea of one who is a relative or biologically related. Instead, it uses the words "bone and flesh" to note biological relations: Genesis 2:23, "And Adam said, This is now bone of my bones, and flesh of my flesh: she shall be called Woman, because she was taken out of Man."

Ephesians 5:30, "For we are members of his body, of

his flesh, and of his bones.

In modern language, those speaking these verses might have said, "you are of my blood." But that meaning did not exist in biblical times, so they used "bone and flesh." If our verse in question (Acts 17:26) had said, "God has made all men of one bone and flesh", the egalitarians might have a fair argument. But, as it is with "blood", they have no argument

Since we are not talking about genetics in Acts 17:26, we could admit that all people do have the same "blood" (in the sense that blood means "the essence of life"). Mankind, humankind, and animals all have this "essence of life". Blood carries oxygen, nutrients, and antibodies to the cells

and tissue and takes away the carbon dioxide and waste. All races and mam-

mals have that in common.

The subject of our verse in question

is not blood, but nations.

"And hath made of one blood all nations of men for to dwell on all the face of the earth, and hath determined the times before appointed, and the bounds of their habitation" (Acts 17:26, KJV).

The verse does not say that individual men are from one blood, as this verse is often read, but rather that nations (which consist of men) are from one. Most people do not see this because of the erroneous teaching (and lies) of egalitarians such as A.I.G. In our society, nearly everyone has a mental block regarding race. Once we understand that the issue is nations, we

can see that the word blood only confuses the matter. The word "from" is more important than the word "of," and it

should be interpreted that way:

"And He made from one every nation of men to dwell upon all the face of the earth appointing the times ordained and the boundaries of their settlements" (Acts 17:26, CNT).

Even if the word "blood" belongs in the verse, it cannot mean the equality of all races, because the verse uses the word "men", which in biblical terms means "Adam." He was the first white man and wherever the word "man" is used in the Bible, it refers to the Adamite. Other bipeds of color are human, and are properly not considered men in the Bible. This is all that the verse is speaking of; it is not including everyone on planet Earth.

One Man

If not one blood, then one what? It is one man. That man was Adam, the first White man who was placed by God to take the position of authority in the garden, to be fruitful, and to multiply. Adam provided the racial line descended from Seth.

Bullinger's Companion Bible: One Blood - The texts omit "blood." The "one" here means either Adam, or the

dust of which he was formed.



The Interpreter's Commentary: from one (some manu-

scripts add "blood"), i.e., from Adam.

Peake's Commentary on the Bible: "From one." The Western text adds 'blood', probably failing to realize that the reference is to Adam.

But, we should remember that the verse would not read, "God has made of Adam all men." Rather it would say, "God had made from Adam all nations." In this verse, Paul is stating biblical history to the Greeks.

This is the cross reference to our verse in Acts:

"When the Most High divided to the nations their inheritance, when He separated the sons of Adam, He set the bounds of the people according to the number of the sons of Israel" (Deut. 32:8, KJV).

Notice how similar this is to Acts 17:26. The N.T. is based on the O.T. and the Bible is its own commentary. Adam is the man that God used to create Adamic nations. These are the only nations of which Yahweh had a purpose

and a Covenant destiny. Notice, the sons of Adam were "separated" and the borders (natural or figurative) were established according to the sons of Israel. Certainly, there is no multiracial society in existence under these "This is the historical conditions. record of Adam's generations. When God created mankind, he made them in his own likeness" (Gen. 5:1, ISV). Adam's descendants became nations spoken of; and they were White (as any lexicon will admit). This was the beginning of the kingdom of God on Earth.

Two Family Trees

Did all races come from Adam? A.I.G. says yes, in order to justify their theory that "race" is a "social construct" and therefore it is normal to marry among all humanoid bipeds. However, Eve also bore Cain, who married and had his own family tree of descendants. Thus, there are two family trees: one from Cain and one from Seth. One was wicked and the other righteous. Therefore, not all races on the planet came from one man. Then why does our scripture in question speak about one man? Because the Bible is God's revelation about the salvation of one racial line of descendants, i.e., the Israelites, God's Covenant creation. The lines of Cain are cursed and are not the objects of God's grace. They are not included under the Covenant.

We assert that all the races did not come from Adam. Some races or "people groups" came from the line of Cain.

There has always been enmity and conflict between the descendants of Cain and the descendants of Seth. "And I will put enmity between thee and the woman, and between thy seed and her seed; it shall bruise thy head, and thou shalt bruise his heel" (Gen. 3:15). Although most churches have never considered the truth found in this verse, it is undeniable that there are two seed-lines in view here. T

Science tells us there were civilizations older than the time of the Bible. The Bible is simply silent on those pre-Adamic periods because it is the history of Adam, not these other races. The Bible tells us that Cain traveled to the east (Gen. 4:16); There in the land of Nod, Cain married and built a city. It is evident that a "city" is filled with people. These were not Adamite and not people of God. It is foolish to think that Cain married one of his sisters (from Eve), for who in the family would permit a murderer to marry their daughter.

Genesis 3:15 Summary - All of the false judeo-Christian churches try to say that the only meaning behind Genesis 3:15 is the future coming of Jesus Christ. While this is certainly true, the main import of racial consciousness in this verse is left out, or deliberately ignored (partly because of the tainted Masoretic Text).

means elsewhere, and that theologians who think otherwise are "polemic." Surely somehow these "polemic" [a strong verbal or written attack] theologians are well-represented today, and we who agree with Gesenius are

accused of polemicism! - Finck

Therefore, the woman's "seed" of Genesis 3:15 is the entire line of Adam's descendants through Seth; which of course includes our Lord Jesus Christ, but not Him exclusively.

Strangers in the Bible

judeo-Christian of the "Answers in Genesis" persuasion may ask, "Is there any proof in the Bible that other races exist?" Yes! The verses

where God told Israel to kill the cursed races (of Canaan) in the land; and the races mentioned that are classified as "beasts of the field"; there are also places that refet to the "stranger" (or alien).

There are two sets of original words that have been translated into the words stranger, strangers or alien. One set of Hebrew words refers to a "stranger" as one who is an Adamic kinsman of the Israelites. The other set refers to the "stranger", that is of another race. Here is just one example of the stranger indicating the same race.

'And he said unto Abram, Know of a surety that thy seed shall be a stranger in a land that is not theirs, and shall serve them; and they shall afflict them four hundred

years" (Gen. 15:13).

The word "stranger" here is "geyr" (H1616): "properly a guest; by implication a foreigner: - alien, sojourner, stranger." There is one Hebrew synonym for this word: toshab (H8453). It is found in Leviticus, and means practically the same thing.

And the sabbath of the land shall be meat for you; for thee, and for thy servant, and for thy maid, and for thy hired servant, and for thy stranger that sojourneth with

thee" (Lev. 25:6).

These are verses speaking of the same kind of people. In both cases, there is no implication of hostility or ill will.

The set of Hebrew words that refer to a "stranger" of another race are: nakar, noker, nekar, and nokriy. These words connote a very different view of the word "stranger" than the others. Nokriy is defined: "From H5235 (second form); strange, in a variety of degrees and applications (for-

eign, non-relative, adulterous, different, wonderful): -

alien, foreigner, outlandish, strange (-r, woman)."

The placing of the word adulterous with words: non-relative, alien, and outlandish is significant. In ancient Israel, sex with a non-Adamic person was considered adultery. Furthermore, study of the Greek words of the Septuagint that mean adultery, also confirm that this is true. The English word, adulterous, means "something mixed." This is the way that Strong is using the word. Clearly, relations with this kind of "stranger" led to dire consequences then, and are still a curse today. This "stranger" is one of another race (not Adamite).

"Thou shalt in any wise set him king over thee, whom the LORD thy God shall choose: one from among thy

brethren shall thou set king over thee; thou mayest not set a stranger over thee, which is not thy brother" (Deut. 17:15).

In this verse, nokriy (H5237) is used. Evidently, God Almighty does not believe that all races are brothers.

Another Hebrew word translated as "stranger" in this sense is the word zuwr (H2114). It means: "to turn aside; hence to be a foreigner, strange, profane; specifically, to commit adultery." Again, note the connotation of adultery. The word zuwr first appears in Exodus:

"And they shall eat those things wherewith the atonement was made, to consecrate and to sanctify them: but a stranger shall not eat thereof, because they are holy" (Ex. 29:33).

As has been proven, the English word "stranger" can mean two different things: either a racial brother living in another location, or a racial alien.

Furthermore, when the Greek Septuagint is used, the exacting language of the Greek makes these issues of race quite

clear. Over and over, in the Septuagint, the word allogenes (allos = another, genos = race) is used to show prohibitions regarding these kinds of "strangers." Properly interpreted, this word means "of another race." To deny that races exist is to reject the meaning of the Greek. This word, allogenes (another race), should be remembered as great ammunition (the "silver bullet" or nemesis) against those who come against us saying, "there is no race," for it proves them wrong. They may not accept the two types of "strangers" (as found in the KJV) but how can they deny a second witness of the truth as found in the Septuagint (allogenes), which our Lord Jesus used as the Word of God. If you remember nothing else in this sermon, do not forget this word (Greek: Allogenes).

Conclusion

Did all the races come from Adam and Eve, as Answers in Genesis and others teach? They claim that Adam and Eve were "mid-brown" and carried the genes for the other races. Through the process of what they call "speciation", the other races appeared. But this theory is a genetic impossibility; for hybrids (heterozygous) do not

produce their own kind. Once a population becomes hybrid (mixed) they continue to produce hybrids. It would be infinitesimal for one of them to find the complete genetic package to result in the "speciation" of the four major races we see today (Caucasian, Negroid, Mongoloid, and Dravidian).

According to Dr. Larry Blanchard,

"The earliest date of the biblical flood is 3275 B.C. using the Septuagint dates. Archaeology has unearthed drawings made on some walls in Egypt depicting four distinct races that dates back to 3000 B.C. That means that this remarkable process of "speciation" took place in less than 300 years! There is no possible way, apart from divine intervention, that this could happen. It would require far more faith to believe this fantastic theory then to simply

acknowledge that God in His sovereign wisdom created the different species and races we see today." – Did All Races Come from Adam, p. 90.

The sixth commandment says, "You will not mongrelize (Exodus 20:14 & Romans 13:9). This is the true meaning of the Law, not as it is usually translated as "adultery" which commonly is defined as "marital infidelity." In these two references, the original words for "adultery" are defined Strong's dictionary as "to commit adultery." What's wrong with this picture? Didn't your teacher in school tell us we must not define a word using the same word? The teacher was right! In our Exodus reference of the KJV Bible the word is naw-af, which in Strong's means: "adultery, woman that breaketh wedlock. And, in our Romans reference, the word is moicheuo, which in Strong's means: "to commit adultery." Now while there is some truth in these definitions, overall they are misleading and incomplete, thus left open to any private interpretation. The dic-

tionaries and lexicons have changed over the years, and newer editions usually copy from the previous editions.

The word for "adultery" is the Greek word, moicheuo.

This family of words is found throughout the Bible. It is used in the Septuagint (Exodus ref.) and the New Testament (Romans ref.). According to the Theological Dictionary of the New Testament by Gerhard Kittel, it means, "of the intermingling of animals and men or of different races." That is quite a difference in meaning (and another "silver bullet" for the race-mixers)! This definition is the classical definition of mongrelization. In the Latin Vulgate, the Latin word is adultero, which means: "To mix (a substance or kind) with another, adulterate: to impair the purity or strength of, to give a variety of appearances to, change... to corrupt, debase" (Oxford Latin Dictionary). Here again, a similar definition; and when this is applied to people, we have mongrelization. Therefore, we find an ancient agreement between the Greek and Latin meanings of these verses, i.e., an explicit prohibition against miscegenation. These definitions should be enough to convince any intellectually honest person of the truth found in the Bible.

The lesson here is to beware of those who come citing Greek and Hebrew words to support their race-mixing views, because they may be using the wrong dictionary. GENETICALLY MODIFIED SEEDS: Conceived as a Weapon

GM seeds and GM food carry great risks for all nations, so much so that for many reasons it is probably imperative these foods be banned outright. This subject is too large to be discussed here, but one aspect requires brief notice. If we were to ask about the origin of GM seeds how the idea was conceived and developed, who did the research and who provided the funding, how would we reply? We might reasonably suggest that the concept originated in the Biology or Agricultural Department of some university, or that a government lab doing research on food supplies might have conceived and pursued the idea. Or, we might suggest a private company in the agricultural field was looking for more productive varieties of grains and stumbled on the process.



We might suggest all those answers, but in each case we would be wrong. GM seed was conceived, promoted, researched and funded by the US Department of Defense the American War Department. GM seed was never meant as a way to feed the hungry, but was instead conceived and designed as a weapon, or more precisely, as a weaponsdelivery system. Genetically Modified seed was never intended to support human life, but to eliminate it.

GM seeds is neither more productive nor healthier than traditional heritage crops, and is far more expensive and destructive, but it presents almost irresistible military advantages against any nation that becomes dependent on this source of food grains. One is that the US can use it as a political weapon, refusing to supply seed to a disfavored nation, perhaps causing widespread famine and dislocation.

The other is more sinister, in that many groups have experimented with genesplicing technology, inserting unrelated DNA into various seeds.

In one case in Canada, a government department discovered an "antifreeze" gene contained in the blood of fish living in Arctic waters, permitting them to survive in waters of sub-zero temperature.1 The scientists spliced this gene into Canadian wheat crops, permitting the wheat to withstand freezing temperatures without damage. Monsanto also forced these genes onto tomatoes, resulting in the first GMO tomato.2 An American research lab spliced the genes from fireflies into tobacco plants, producing a tobacco field that glowed in the dark.3

These examples may be harmless, but others are much less so. The US Defense Department has invested huge

sums in research directed to splicing lethal genes into these GM crop seeds, including smallpox, bird and swine flu viruses, corona viruses, the plague, AIDS, and more. As a military weapon such science is priceless. Why begin a shooting war when Monsanto or Cargill can sell rice, corn, and soybeans that contain smallpox, HSN1. or a corona virus? When the seed is harvested and passes into the nation's food supply it could, within weeks, exterminate 50% or more of the population without firing a single shot.

And this was precisely the reason GM seed was conceived and developed by the Americans. It is a weapon of war, designed and meant to deliver to a nation's entire population a lethal virus or other disease, to literally exterminate an enemy with no risk to the aggressor. Many scientists and US military documents have demonstrated that seeds are far cheaper and much more effective than bombs in the search for military domination. One such military document I've discussed elsewhere stated the cost per death of an enemy population by nuclear, conventional and biological weapons, the latter being orders of magnitude less than the former.

Genetically Modified Politicians: Their Battle to Persuade the Public to Accept GM Food

In 2001 scientists at the Epicyte bio-lab in San Diego created a GM contraceptive corn, having discovered a rare class of human antibodies that attack sperm. Their researchers isolated the genes that regulate the manufacture of these antibodies and inserted them into corn plants, creating horticultural factories that make contraceptives.4.5 Shortly after the 2001 Epicyte press release, all discussion of the breakthrough vanished. The company was taken over by Biolex and nothing more was heard in any media about

the development of spermicidal corn. Epicyte, DuPont and Syngenta (sponsors of the Svalbard Seed Vault) had a joint venture to share and use this technology. Silvia Ribeiro, of the NGO ETC Group, warned in a column in the Mexican daily La Jornada, that "The potential of spermicidal corn as a biological weapon is very high," and reminisced about the use of forced sterilizations against indigenous peoples.

The Doomsday Seed Vault at Svalbard

A new and serious cause for concern is the recentlyannounced seed vault built on a piece of barren rock named Svalbard, which is owned by Norway., is very remote near the North Pole, and virtually inaccessible. According to press releases, the seed vault has dual blast-proof doors with motion sensors, two airlocks, and walls of steel-reinforced concrete one meter thick. There are no full-time

staff, but the vault's relative inaccessibility will facilitate monitoring any human activity. The stated purpose is to share the entire world's heritage seeds so that crop diversity can be saved for the suture, but that crop diversity is already "saved," stored in vaults all around the world. What do these people foresee, that such a remote and secure

facility should be developed?

DISOBEING GOD'S FIRST CREATION ORDER TO MAN "BE FRUITFUL AND MULTIPLY"

Immediately after God created man in his own image and likeness, "God blessed them and said to them, Be fruitful and multiply; fill the earth and subdue it'." (Gene-

sis 1:28). This blessing and order were repeated after the Flood; "Then God blessed Noah and his sons, saying to them, 'Be fruitful and increase in number and fill the earth" (Genesis 9:1). We read that "Sons are a heritage from the LORD, children a reward from Him. Like arrows in the hands of a warrior are sons born in one's youth. Blessed is the man whose quiver is full of them" (Psalm 127:3-5), and that Blessed are all who fear the LORD. who walk in his ways. You will eat the fruit of your labour; blessings and prosperity will be yours. Your wife will be like a fruitful vine within your house; your sons will be like olive shoots around your table. Thus is the man blessed who fears the LORD (Psalm 128:1-4). It is the burden of this paper that most people in the so-called Christian West have disobeyed God's first creation order/command to man, have despised His promised blessing attached to it, and will therefore be

stripped of dominion and prosperity in favour of other people who have obeyed God's first creation command to man.

Factual and statistical information substantiating this charge comes from the well-researched article The Cost of Wholesale Contraception by James A. Miller, Miller reports that on May 9, 1960 the U.S. Food and Drug Administration approved the birth control pill as safe for contraceptive or birth control use. At the same time the Pill also began to be taken by Western European women. This marked the end of the baby boom and beginning of the disastrous Sixties. At first the Pill's effect was slow, but births began to decline from an all-time high of 4.3 million in 1957 by more than 16 percent in 1964. By 1965 the American birth rate had declined to 19.4 a level barely above the rate of the Great Depression. Birth rates kept declining till an all-time low of 14.6 in 1975. This decline took place, amazingly, amidst mounting propaganda for "zero population growth" spearheaded by Dr. Paul Ehrlich's 1968 book, The Population Bomb.

The first to feel the consequences of this demographic development were the maternity wards of hospitals, and next, the manufacturers of baby food such as the Gerber Products Company, which suffered a decline in sales for

the first time in its history in 1973 and whose earnings fell 50 percent between 1973 and 1974. Other baby food companies and maternity shops likewise declined or even went out of business. Developments in other Western nations were similar.

were similar.

On May 9, 1968, exactly eight years since the Pill was approved, the American College of Obstetricians and Gynecologists promulgated a new policy asking that "social and economic factors" be considered in allowing abortions. In 1970 the American Medical Association adopted a similar policy. Public demand for legalized abortions also arose to "contraceptive failure." Abortions in the USA now number an estimated one and a half million annually and may rise substantially as the administration removes legal barriers still left from previous administrations. Abortions around the world number around 55 million annually.

American elementary schools were next. From 1979 to 1982 children entering first grade were a million fewer each year. In 1985 there were nearly eight million fewer elementary school students than in 1969. This decline caused a surplus of elementary and intermediate school

buildings and teachers.

Not only the Pill but sterilization chosen increasingly as the surest and permanent means of birth prevention (i.e. abortion before the fact) took its toll. In 1965, 73 percent of American husbands and wives aged 15 to 44 were able to have children; this total declined by 52.7 percent by 1982. At the same time, the share of wives or husbands who had been surgically sterilized climbed from 15.9 percent to 38.9 percent according to a study released in February 1985 by the US National Center of Health Statistics.²

Next the high schools were "Reeling from the birth dearth of the late 1960s and early 1970s." (American Demographics magazine). Colleges broadened admissions, lowered their retention standards, or else recruited overseas. The highly visible presence of many third world students on American college campuses today is largely due

to this development.

The economy at large began to suffer as the absence of millions of customers, contracepted or abortedout of existence took effect. Consider especially the declining need for new housing, which is the place setter for the rest of the economy. Experts predict that total new housing starts including rental apartments, which already dropped from 1.75 million units in the 1970s to 1.5 million in the 1980s, will fall to about 1.1 million by the mid 90s. This situation may continue well into the net century and be relieved only by immigration. Incidentally, housing built since the 1960s reinforces the birth dearth cycle by making little if any provision for large families. Today the rare Christian couples obeying God's creation command to be fruitful and multiply must almost invariably do with old obsolescent housing in decaying neighbourhoods to shelter their children.

As is becoming well known, contraception and abortion threaten the Social Security systems in the West. The ratio of workers to retired persons is expected to drop from 4-1 now to about 2-1 soon. Miller writes that "The only visible answer is young, tax-paying immigrants.," As to Europe, it is slowly vanishing. In nation after nation, the number of births occurring annually has already fallen

below the number of deaths. Germany, Switzerland, Austria, Great Britain and Hungary slipped into natural population decrease during much of the 80s.

Some of the lowest fertility rates ever registered in all human history - about 1.3 children per woman, more than 40 percent below the zero-growth rate - have been registered in such "Catholic" countries as Italy and Spain. The fertility rate for Europe as a whole has been running about 1.6. Recent demographic projections have put Western Europe's population in 2050 at a hundred million fewer persons. Hugh social disruptions are already occurring as millions of immigrants from Africa and the Middle East flood the emptying continent next to them.

The same inexorable logic applies in the US throughout the developed world. People from healthy birth rate nations are being recruited into below replacement nations. Throughout the industrialized world, Xenophobia is appearing along with these; an economy going sour, families breaking, sexual diseases rampant, abortions rising.

In what can only be called an addiction to the Pill, nation after nation is literally losing the will to reproduce and survive. Miller's sobering report ends here. Add to it

that in Europe many of the immigrants are Muslims who in some instances are buying unused empty formerly Christian churches to transform them into mosques and demand that Muslim law (the Sharia) replace the law of the country in districts where they have become a majority (it has happened in England.). Their leaders are well supplied with financial resources for expansion and proselytizing by oil-rich Arab governments. If this development continues, it will mean a rude chastening for the vast majority of European secular materialists and severe persecution like in most Islamic countries today, for the small Bible believing Christian minority.

Now the Muslim people did obey God's first creation order to be fruitful and multiply, and this is why Islam is the world's fastest growing religion today. It is estimated that Muslims will number 1.9 billion people, or 25 percent of all humanity, by the year 2020. Europeans, on the other hand, including

European Christians, did not even replace themselves. Thus the Muslim people may accomplish the hegemony of Europe in the 21st century which they failed to obtain by war five hundred year ago. As to the United States, Hispanic immigrants may well recover by sheer population pressure the American South-West wrested from Mexico a

pressure the American South-West wrested from Mexico a hundred year ago. Disobedience of God's first creation command to be fruitful, multiply and fill the earth characterizes the overwhelming majority of Western Christians. Not God their Creator and Lord, but the wealth and wisdom of this world is evidently first and foremost in their minds when it comes to having children. This materialistic attitude prevails in almost all churches as well. No sermons are being preached about God's first creation commandment, nor about the clear implication of Roman 12:1, which entreats Christian believers to "present your whole bodies as living sacrifices. holy and pleasing to God, which is your reasonable (or spiritual service." We are not obeying this Biblical, New Testament call when we withhold our bodies reproductive capacity from our Lord. Yes, some dear couples cannot have children or not as many as they would like, for child-

bearing is a gift from God's hands (Genesis 16:2, 21:1-2,

25:21, 30:2, 1 Samuel 1:19, Luke 1:25, 36:-37, etc) With others one spouse yearns for more children while the other is adamantly opposed; the Lord knows their thoughts and innermost hearts (Psalm 139:1-4) Many Christian couples, like their non-Christian contemporaries, were voluntarily sterilized in the 1970s and 1980s. Now a few of them, persuaded of the unbiblical nature of this step, obtain reversals

and rejoice in more children.

All this is in stark contrast to the Russian Christians persecuted under communism. SO, WHAT'S WRONG WITH OUR FOOD TODAY by Vivien Cooksley

At the turn of the 21st century there are many foods that have been devalued, altered or contaminated by man. This is the result of modern farming and processing techniques by over processing, over refining (e.g. white bread, white rice, white sugar, white salt, etc) and the use of agricultural chemical fertilizers, i.e. nitrates, superphosphate, herbicides, pesticides, fungicides. Then there is the addition of chemical fillers, enhancers, artificial dyes and sweeteners, emulsifiers, bleaches, preserva-tives, solvents, pollution of our air via transport and industrial fuels and our water via fluoridation and chlorination. In the year 2005 there were over 100,000 synthetic chemicals permitted for use in Europe alone. In today's life-

style many people are busy, tired, stressed and sedentary, the end result - people are facing enormous problems with

their health.

God's instruction in Leviticus 25:3-5 was to rest our crop pastures every seven years. This practice allowed the soil to regenerate a nd restore a good balance of minerals. The rotation of crops was also beneficial to establishing nutritional soils. In our society these two practices are seldom undertaken today. If we have healthy soils, then in turn our plants will contain life-giving nutrients and be disease resistant. The same applies to the human body - eating healthy foods produces a healthy body.

Another change in our eating habits came about when refrigeration became available to the general population in the mid-20th century, this brought about an increased consumption of animal foods. Meat lacks the plant nutrients to combat disease and to build the immune system. Few people realize our farm animals are injected with growth hormones and antibiotics, these substances are eventually deposited into their flesh and milk and subsequently pass on to humans. Our bodies are able to cope well with 'small' amounts of animal meat and 'small' amounts of animal milk and its by-products e.g. yoghurt, cheese etc...However, if we regularly eat a considerable amount of the animal foods and limit vegetables, salad item, fruits, uncooked



nuts, seeds and whole grains, the consequences of incorrect

eating could well be illness and disease.

A new form of food production is Genetically Modified (GM) plants, the results of which are still being evaluated and the benefits are highly questionable - are they really needed at all? Genetic Engineering (GE) involves the removal of a specific gene from one plant and inserting it into another totally unrelated plant, this crossbreeding would never occur in nature, nor are these plants as God designed them. Recent observations have shown that many bee colonies have been wiped out, why, they will not feed from G.E. plants. We need bees to pollinate our plants.

Also, today there is little water, this has been replaced with a variety of sugary or chemically sweetened soft drinks (check your labels for the amount of sugar in everything, it will shock you!) Black tea (not herbal teas) and coffee are diuretics, so the body actually loses more water than it takes in. Water is the best self-defense against illness as it maintains an alkaline bloodstream, keeps the body hydrated, maintains a good blood volume, increases circulation by thinning the blood, enabling it to carry life giving nutrients to all living cells and transports waste matter from the body. Water is also the main component of blood plasma and carries oxygen to the body's cells to provide heat and energy. (Adults should drink between 2 to 3 liters of water per 24 hours)

In addition to all these things is the negative effect of long-term cold storage of our fruit and vegetables, this storage diminishes their nourishing vitamin/mineral content, in some cases significantly. It may be months before we consume these foods, yet they are sold as 'fresh' foods.

We always seem to hear about the Aboriginal stolen generations but never "The White Stolen Generations," Which was much larger than the Aboriginal babies taken from their mothers.

Did you know that in Australia there is another stolen generation, one which shares the pain and consequences? It's called the "white stolen generation" to distinguish it from the Aboriginal stolen generation.

In the five decades up to 1982, the newborn babies of young single women were forcibly removed from them for adoption, a practice sometimes called 'baby farming'.

Mothers were drugged, tethered to beds, not allowed to see their babies, told they were dead. Many of these adoptions occurred after the mothers were sent away by their families due to the sigma associated with being pregnant and umarried.

More than 250,000 white mothers lost their babies to forcible removal at birth by these past illegal adoption practices. Groups such as Adoption Loss Adult Support and

Apology Alliance offer help and support.

Between 2010 and 2012 apologies were offered by Western Australia, South Australia, ACT, New South Wales, Victoria and Tasmania. Prime Minister Julia Gillard offered a national apology to these affected by forced adoptions in 2013.

It is true that Aborigines were here before the white man but it is also true that the white man built Australia into what it is today.

A more specific truth is that those people that built Australia were not immigrants, they were Anglo Celts, they were the British race. Paul Sheehan in *Among the Barbar*-

ians, stated it as follows:

"The half century 1947 -1997 saw a social revolution in Australia that was bloodless, democratic and open-minded. In 1947, the Australian population was just 7.5 million; it was ninety percent Anglo-Celtic; it was ninety nine percent European; the Aboriginal and Asian population were less than one percent of the overall population; public policy still enshrined White Australia, which had helped define the nation since independence: links with Asia were minimal; the British Privy Council was still the ultimate court of appeal. Aborigines did not have citizenship, and had barely any role in society (emphasis added)." (P.39).

So the simple fact: until after the Second World War Australia of essentially totally British stock, the culture was English and the relevant civilization was Anglo-Saxon. The political system was the English Westminster System, the law of the country was the English common law and the religion was Christianity. As Paul Sheehan makes clear this had been the case from 1788 until very recent years.

This is a truth. If it is true to say that the trees belonged to the Aboriginals it is equally true to say that everything that the eye could see in 1950, that had been built by a single culture and a single race. But this is one truth that cannot be placed in the preamble. No, it is not racist to say that the Aboriginals were here first. It is only racist to declare in the Constitution the name of the people whose ingenuity and hard work built the country.
